 A Canada West Point.  
 It has been removed from time to time that, among other institutions of the United States, the Government of Canada contemplated the establishment of a Military School for the training of young army officers. We know, of course, that there were many who longed for such an establishment, and that there were several who longed to the Government who would like to get Professorships in a school of the kind, and that there were persons ready and anxious to have their sons educated for civil engineering at the public expense; but we did not for one moment suppose that the Government—the economical Government, the reform Government, the Government in which Mr. Burgess holds a seat—would pander to the blood-sucking snobbery that demands the "fastening" of a Military-School leech upon the treasury of the Dominion. But we were mistaken in this, as in every other good opinion we ever had, and the Government has decided to do it. The Military School is to be established! The people of Canada are to be taxed for a Canadian imitation of the West Point school! The debt of this country is to be increased for the education of the sons of the office-holding class! This is to be done in the name of defence, of course! That our readers may not accuse us of manufacturing this damaging charge against the Government—a charge that needs the most indisputable evidence to secure its being believed by their supporters in this quarter—we quote from the official confession in the *Toronto Globe*, as follows:

The Hon. Mr. Ross will soon move a series of resolutions in Committee of the whole House, and this will be the initiatory step toward the foundation of an institution, which, we hope, will be fruitful of great advantages, and which will do credit to the Government. At present a military college as one of the earliest steps toward the education of young men in order to qualify them as officers. The institution would be under the control of a military officer, qualified by statements and experience for the office, and would be under the supervision of the Government. The term of instruction would range over four years, and the establishment would be subject to regulations made by the Governor in Council.

There are to be Boards of Examiners in the several Military Districts, and candidates must be within sixteen and twenty-one years of age. There are to be exceptions, of course, as it would not do to put it out of the power of the Ministers to serve their friends with military commissions. The Government is to be a military college as one of the earliest steps toward the education of young men in order to qualify them as officers. The institution would be under the control of a military officer, qualified by statements and experience for the office, and would be under the supervision of the Government. The term of instruction would range over four years, and the establishment would be subject to regulations made by the Governor in Council.

Some of Mr. Mackenzie's admirers were greatly relieved at the news that he had unexpectantly pledged himself not to apply for an amnesty for Riel. The St. Stephen shipbuilders have agreed to reduce the rate of wages paid to their carpenters, and the latter are to go to leave for other fields of labor.

R. J. Ritchie, Esq., of this city, lectured in St. Stephen Friday evening on Temperance, under the auspices of the Catholic Temperance Union.

On Tuesday a lad aged fourteen, named Bellows, of Milltown, was caught by the rebelling in P. H. Boardman's mill, and carried into the raceway and drowned.

The married ladies of Calais are organizing to celebrate a temperance crusade. Calais especially requires this work, as it has a Prohibitory Liquor Law.

Joseph F. Brennan has retired from the editorial management of the *Prince Edward Islander*, which position he has held for over eighteen months.

A man named Lickletter was robbed of two hundred dollars in Summerside, P. E. I., on Tuesday last, in a house kept by a Frenchman named Doirant.

A Murry Harbor correspondent of the *Charlottetown News* gives the particulars of the drowning of Mr. James Lamson of that place, while engaged in making fast the schooner E. Chambers, a short time ago. His body has since been discovered.

**City Police Court.**

They arrested her, and to the charge of being a loose character and having no continuing abiding place she pleaded guilty. The next two months of her checkered life will be spent in the penitentiary.

**Parliament of Canada.**  
 (Special to the News.)  
 OTTAWA, April 8.  
 In the House to-day petitions asking for prohibitory law were presented, the signatures to which numbered nearly twenty thousand.

A message was read from His Excellency Lord Dufferin, thanking the House for the address.

In reply to Mr. Condon the Premier said his answer to Mr. Palmer yesterday was that the Government did not intend applying for a pardon for persons of offences committed in the North-West, at the present time.

In answer to Mr. Palmer, Hon. Mr. Mackenzie said the question of putting a sum in the estimates for the erection of a Marine Hospital in St. John was under consideration.

The prohibition liquor law petitions were referred to a Committee.

The Premier presented the report of the Minister of Agriculture.

When the orders of the day were called respecting the examination of Attorney General Clarke, attendance of Riel, and the examination of Policemen, Mr. Condon moved that all three matters be postponed till Friday.

Mr. Powell insisted upon calling on the two latter orders.

Mr. Palmer moved an amendment that the first order of the day be postponed.

Mr. Holton moved an amendment that all three orders be postponed till to-morrow.

After some discussion Mr. Holton's amendment was carried.

Mr. Cartwright stated that he would not be prepared with his budget speech this week.

House then adjourned till to-morrow.

Hundreds were disappointed in gaining admission to the galleries to-day. Among the crowd inside and outside were five hundred Frenchmen from Hull and the Galleries.

The latest rumor concerning Riel is that he will surrender to the Quebec authorities in order to prevent Mr. Bowell's motion for expulsion from being carried, it being based on the ground that Riel is a fugitive from justice.

The French members seem determined he shall keep his seat and escape justice by being tried in Quebec. It is stated positively that if Riel will keep away and stand his trial the Government guarantees to secure his pardon in case of his conviction.
