Order,—Briefs received providing criticisms of Bill No. 248, session 1957-58: Mr. Benidickson, 234. Presented, 252. Sess. Paper No. 209.

Estate Tax Act, Bill:

Resolution,—To replace Dominion Succession Duty Act, to provide that tax be computed by reference to property comprising estate of deceased rather than property contained in bequests from estate to beneficiaries; and to consolidate, revise and simplify tax law: Resolution adopted, 239. Bill No. C-37, Minister of Finance, Act respecting Taxation of Estates, 1st R., 240. 2nd R., and referred to *Banking and Commerce Committee*, 261. Reported with amendments, 296. Committee evidence and proceedings recorded as Appendix No. 5 to *Journals*, 296. Considered in Committee of the Whole, 375, 405. Reported with amendments and considered as amended, 3rd R., 405. Passed by Senate with amendments, 512-3. Amendments concurred in, with exception of fourth, 533-4. Senate does not insist upon fourth amendment, 549. R. A., 576. (7 Elizabeth II, Chapter 29).
