The treaty, commonly known as the Quadruple Pacific Treaty, between the United State of America, the British Empire, France, and Japan, for the preservation of the general peace and the maintenance of their rights in the region of the Pacific ocean, which was concluded at Washington on December 13, 1921, and which terminated and superseded the agreement between Great Britain and Japan, concluded at London on July 13, 1911, commonly known as the Anglo-Japanese Alliance, was signed and ratified on behalf of Canada.
