Question No. 136-Mr. Caouette:

Were any regulations made under section 83 of the Financial Administration Act with respect to conditions upon which a corporation acting the for the crown may undertake contractual obligations and, if so, what are they?

Hon. E. J. Benson (Minister of National Revenue): 1. The government contracts regulations, P.C. 1964-1467, issued September 23, 1964 under the authority of sections 39 and 83 of the Financial Administration Act (R.S.C. 1952, c.116), declare in section 2(1) (d)(ii) that the regulations apply to the corporations named in schedule B to the Financial Administration Act and the National Capital Commission, National Battlefields Commission and the Northern Canada Power Commission.

AIR CANADA DC-9 SERVICE

Question No. 157-Mr. Forrestall:

1. What cities in Canada are to be included in the introduction of DC-9 aircraft to Air Canada domestic service routes?

2. What dates are now anticipated for such in-

troductions?

3. What will be the frequency of such service between Halifax and Montreal?

Mr. J. A. Byrne (Parliamentary Secretary to Minister of Transport): The management of Air Canada advises as follows:

1. The following cities in Canada are included in Air Canada's plans for DC-9 aircraft operation in the first half of 1966: Vancouver, Edmonton, Calgary, Winnipeg, Toronto, Ottawa, Montreal. Other points of call are likely to be added in subsequent years as additional aircraft become available.

2. Vancouver, Winnipeg, Montreal—April 24; Toronto-June 1; Edmonton, Calgary,

Ottawa—July 1.

3. There has been no decision yet as to flights to Halifax.
