### CLOSURE OF ELEVATORS FOLLOWING ACQUISITION OF FEDERAL GRAIN BY MANITOBA POOL—ACTION TO PROTECT FARMERS

**Mr. Robert Simpson (Churchill):** Mr. Speaker, I have a question for the Minister of Justice in his capacity as the minister responsible for the Wheat Board. With reference to the takeover by Manitoba Pool Elevators of the line elevator system of Federal Grain and the consequent announcement of closure of elevators which is causing great hardship for many farmers, can the minister say whether the Wheat Board is looking into these closures with a view to protection of the farmers concerned?

**Hon. Otto E. Lang (Minister of Justice):** Mr. Speaker, I have not had specific closures brought to my attention. These, of course, are ordinarily undertaken by the elevator company concerned on its own examination of the financial situation and presumably with the best interests of the farmers in mind.

**Mr. Speaker:** Order, please. I have to bring to the attention of hon. members that there are only three or four minutes left before the end of the question period, and even that may be stretching the time a little bit. I note that the hon. member for Churchill has a supplementary and he will be recognized for that purpose, but it should be brief.

**Mr. Simpson:** Is the minister saying that he has not had representations to have the Wheat Board look into the situation caused by these closures?

**Mr. Lang:** Mr. Speaker, I said that none had been directed to my attention.
