# PRACTICE RELATING TO CORRESPONDENCE WITH TAIWAN

### Question No. 704-Mr. Cossitt:

Does the Department of External Affairs refuse to permit, or discourage in any way whatsoever, departments from corresponding on any kind of government letterhead when seeking information of any kind from Taiwan and, if so, who made such a decision and for what reason?

Hon. Mitchell Sharp (Secretary of State for External Affairs): The Secretary of State for External Affairs is responsible for the conduct of Canada's foreign relations and, through his Department, for official communications with foreign governments. As for Taiwan, the Canadian Government does not recognize the régime in question. The Department of External Affairs would not, therefore, approve any official communications between any department of the Canadian Government and the régime on Taiwan, and would not normally engage in such communications itself. This is in conformity with generally accepted international practice.

Hon. John C. Munro (Minister of Labour): 1. There are no terms of reference as such. Departmental officials, through internal studies and discussions with labour and management, are exploring methods of impasse resolution in labour disputes other than strike and confrontation methods.
