In view of the contradictory news which has appeared in newspapers concerning the supply of feed grains in eastern Canada, can the minister advise the House whether the current stocks of feed grains in eastern terminals are sufficient to meet the needs of farm producers during the 1974-75 winter?

Hon. Otto E. Lang (Minister of Justice): Mr. Speaker, not enough grain is in position in eastern locations for domestic or export movement for the winter. Ordinarily, the volume of grain would be moving into these positions throughout the lakes and the Seaway; but that, of course, is not possible at present because of the grain inspectors' strike which is going on.

FEED GRAINS—ADEQUACY OF MOVEMENT WHEN GRAIN HANDLERS' STRIKE SETTLED

Mr. Donald W. Munro (Esquimalt-Saanich): Mr. Speaker, I would like to put my question to the President of the Treasury Board.

Owing to the difficulties encountered by the egg and poultry industry because of the grain inspectors' strike, would the government be willing to restore the grants program in operation last year when there was a railway strike, grants intended for feed-grain producers who are compelled to supply themselves from suppliers in other provinces, for instance?

Hon. Jean Chrétien (President of Treasury Board): Mr. Speaker, we have not taken any definite decision on the plan to evade the difficulty. I take due note of the hon. member's suggestion but I am in no position to give him a reply right now.

Mr. Munro (Esquimalt-Saanich): Mr. Speaker, I would like to ask a supplementary question.

Is the minister aware of the danger that this situation might easily degenerate to the point where Canadians might watch on television the nauseating spectacle of chickens dying by the hundreds, and maybe also dying cattle, for lack of feed?
