MEASURES TO INCREASE EXPORTS—MOTION UNDER S.O. 43

Hon. George Hees (Prince Edward-Hastings): Mr. Speaker, I rise to move a motion, under Standing Order 43, on a matter of urgent and pressing necessity.

As it is essential that this country overcomes the \$12.5 billion a year trade deficit which we have in fully manufactured goods, and as this can only be done if we greatly increase our sales effort abroad and let far more people in the world market know what this country has to offer, I move, seconded by the hon. member for Victoria-Haliburton (Mr. Scott):

That this government allow producers to write off 200 per cent of all expenses connected with making sales trips abroad, displaying their products at foreign trade fairs, and any other expenses incurred in sales promotion in the export market in excess of those made in the base year, the year before the plan goes into operation.
