PRORATA PENSIONS—MOTION UNDER S.O. 43

That the House calls on the Minister of Veterans Affairs to include in the forthcoming bill an amendment that would tie the basic rate of war disability pension to the take-home pay of the five categories of public servants previously used to determine the amount of pension, and an amendment providing for prorata pensions to be paid to widows of pensioners assessed at less than 48 per cent.
