**CRIMINAL CODE****MEASURE TO AMEND**

**Mr. John Manley (Ottawa South)** moved for leave to introduce Bill C-273, an act to amend the Criminal Code (gun control).

**Mr. Deputy Speaker:** Is it the pleasure of the House that the hon. member shall have leave to introduce the bill?

**Some Hon. Members:** Agreed.

**Mr. Manley:** Mr. Speaker, the purpose of this bill is to increase the effectiveness of the legislation relating to the control of firearms in Canada. In particular, four basic changes are being proposed with respect to firearms acquisition certificates.

The first is to increase the age limit for obtaining a certificate from 16 years to 18 years of age. The second is to raise the fee charged for the certificates from \$10 to \$100, which should come somewhat closer to recovering the cost of administering the system. The third is to make a certificate valid for one specified firearm. The fourth is to require individuals to provide proof of secure storage for a firearm as a condition before a certificate is issued.

Motion agreed to, bill read the first time and ordered to be printed.
