CANADIAN FORCES BASE NO. 5 SUPPLY DEPOT

Mr. George S. Rideout (Moncton): Madam Speaker, pursuant to Standing Order 36, it is my pleasure to introduce a petition with over 5,000 names questioning the decision to close the Canadian Forces Base No. 5 Supply Depot in Moncton.

The petitioners call on Parliament to reconsider this untimely decision and keep these military facilities where they have been so capably serving the troops, the militia and other bases throughout Canada and overseas for the past 52 years.

NORTH AMERICAN FREE TRADE AGREEMENT

Mr. Dan Heap (Trinity—Spadina): Madam Speaker, it is my honour and pleasure to present a petition from several residents of North York, Toronto, Brantford and Port Dover who are concerned that the North American free trade agreement has resulted in even greater trade concessions being demanded of Canada so that Canadians will lose more jobs and there will now be further restrictions placed on the provincial, federal and territorial governments and even municipal governments from assisting Canadian industry, conserving natural resources and advancing our social programs.

Therefore, these petitioners call on this House to reject the proposed North American free trade agreement and recommend to the government that it use the termination clause to end the U.S.-Canada Free Trade Agreement.

CRIMES OF VIOLENCE

NORTH AMERICAN FREE TRADE AGREEMENT

Mr. Ron Fisher (Saskatoon-Dundurn): Madam Speaker, it is my honour to present a petition, duly authorized under Standing Order 36, signed by people from the city of Regina and the community of Raymore, who point out that the proposed North American free trade agreement will erode Canada's ability to do many things and will also erode Canada's ability to maintain its level of employment.

They point out that if it is implemented, the trade agreement will result in further restrictions being placed on the ability of Canada's federal, provincial and territorial governments, now and in the future, to assist Canadian industry from using the natural advantages Canada has through its natural resources for Canada's own benefit. They ask that because the free trade agreement has to be implemented before January 1, 1994. They call upon the House of Commons to reject the proposed North American free trade agreement.

They also recommend that the free trade agreement with the United States be abrogated.

VIOLENCE AGAINST CHILDREN

We strongly request that this petition be heard as a people's vote to reinstate capital punishment for child murderers and stiffen penalties for child molesters.

If we cannot protect our children from the people who commit these heinous crimes, then who will?

Therefore, your petitioners call upon Parliament to enact legislation against these types of offenders.
