# An Arbitration Plan

Work of the Peace Makers Successfully Concluded.

Storms in Germany-Cr ps Destroyed and Many People Killed.

Paderewski Again Reported to Have Married.

Another Effort on \_enalf of Mrs. Maybrick-Serious Fire in an English Town-300 Families Burned Out-Last Day at Bisley.

The Hague, July 24.—The third committee of the international peace conference held a session Saturday under the presidency of Leon Bourgeois, of the French delegation, and adopted article 9 as modified. The article now reads:

"In international disputes, involving neither country's honor nor essential interests, arising from a divergence of opinion on points of fact, the signatory powers deem it advisable that parties which are unable to agree by diplomatic means shall institute, so far as circumstances will permit, an international inquiry, whose duty it shall be to facilitate the solution of these disputes by clearing up the questions of fact by means of an impartial, conscientious examination." SCHEME AS A WHOLE ADOPTED.

After adopting article 9 and passing the second reading of the five articles dealing with commissions of inquiry, the committee adopted, with slight verbal modifications, articles 36 to 56 of the arbitration scheme, and then adopted the scheme as a whole, bringing the labors of the committee to a successful conclusion.

Count Nigra, head of the Italian delegation, on behalf of his colleagues, thanked M. Bourgeois, who, Count Nigra said, had directed the discussion, "with distinction, authority and impartiality, and in a conciliatory spirit."

The committee will meet formally on Tuesday next to read the minutes of its proceedings, and afterwards a plenary meeting of the conference will be held for the final acceptance of the arbitration scheme. The entire proceedings are expected to be brought to an end by the latter part of this week. leaving.

MANY DEATHS BY LIGHTNING. Berlin, July 24.—The past week has been unusually hot and humid. Heavy rains and hailstorms have occurred in various parts of the country, inflicting much damage to the crops. Many people have been killed by lightning, two such cases having occurred in Berlin. A number were also injured in Berlin. The River Havel at Pots-dam was filled to its banks for several days, and thousands of fish were killed by lightning. Floods are reported in the Spreedwald and in the lowlands of the Vistula the hay crop has been ruined for the second time this season. In Wurtemberg the crops have been

almost totally destroyed. The thunder at Hanover was the most severe experienced for 30 years. Many people in that province were struck and killed by lightning. In Riesengebirge, Silesia, some deaths from sunstroke were also reported. One hundred draft dogs in Berlin were sunstruck during the week and brought to the veterinary station by the police.

London, July 24.—Serious fires have occurred at several places in England, assisted probably by the great heat, which is drying everything up. One of the fires was at Sibbick's yachtbuilding yard at Cowes, which was completely burned out. A number of racing yachts, one of them a forty-six rater, and several boats in course of construction, were completely destroyed. The league is about to form a committee on international law, consisting of Prof. James Bryce, Prof. Dicey and Sir Frederick Pollock, to consider pending questions between the United States and Great Britain from the legal standpoint of view, and to try to suggest terms for their

arrangement. CRISIS IN BELGIUM.

A Central News dispatch from Brussels says that a ministerial crisis has arisen over the franchise question, and several members of the ministry have offered to resign.

INDIA FRONTIER TROUBLE. There is trouble on the frontier growing out of a quarrel between the Khan of Nawagai and sections of the Mahmunds. A battle was fought Friday, in which 100 men were killed and 120 wounded. The Mahmunds were victorious.

PRIVY COUNCIL DECISIONS. The privy council has granted special leave to appeal against the decision of the supreme court of Canada in the case of Hobbs against the Esquimalt and Nanaimo Railway Company. The privy council has refused to allow the Great Northern Transit Company to appeal against a decision in favor of insurance companies in the case of the burning of the steamship Baltic at Colingwood, Ont.

#### LAST DAY AT BISLEY.

was 329. CRISIS IN SIGHT. London, July 24.-The Times' Pretoria correspondent says the Uitlanders have been given to understand that no abatement of the demands made by Sir Alfred Milner will be acceptable to the imperial authorities. A crisis is therefore, now held to be in sight.

At a meeting of Uitlanders in Johannesburg there was decided upon and dispatched a strongly-worded cablegram protesting to the British Government against the acceptance of the seven years' franchise as the basis of a settlement of the Anglo-Boer dispute. The charges against the persons arrested some time ago for alleged con-

spiracy against the government have been reduced from high treason to creating disturbances. Premier Schreiner, of the Cape Colony, absolutely denies the London Standard's accusation that he telegraphed

to President Kruger, exhorting him not to yield to the demands of the Uitlanders. He says he merely telegraphed to President Kruger, advising him not to be premature in passing the franchise law. There is great indignation on the part of the English and anti-Boers against Premier Schreiner, who is under their deep suspicion.

#### CABLE NOTES. Major Marchand's Senegalese sharpshooters created a riot at Toulon Sat-urday because of the non-receipt of their pay. The disturbance was quick-

ly suppressed. The colonial office announces that the bubonic plague has spread from Hong Kong and Mauritius to Reunion. There were 36 cases at Mauritius during the week ending July 20, of which 29 resulted fatally.

London, July 24. - The same general tone of inactivity as last week prevails in the wheat market, the demand from the limited attendance of buyers being restricted and confined to immedlate wants.

Operators, in the face of the ample supplies both on hand and coming forward, combined with the favorable crop prospects, are acting very cautiously.

The supply of home-grown wheat on offer has not increased, but business has been practically at a stand-still, the rates being nominally easier, Foreign sorts have been offered to a fair extent, and with no revival in inquiry a very flat state of affairs is characteristic. Even a general de-preciation of 6d per quarter is not leading to any appreciable increase in the volume of trade doing.

year. # CASES IN COURT

Aftermath of the Disturbances on the 8th Inst.

Till Next Monday. Riot cases arising out of the street railway troubles on Saturday, the 8th inst., pretty nearly monopolised the attention of the police court this morning.

One case was dismissed on the preliminary examination. Two men were committed for trial at the assizes, and one case was emerged till Thursday. All cases of alleged disturbances after the riot act was read were postponed till Monday, 21st inst. Alfred Deardon was charged with

throwing three stones at a street car on Saturday afternoon, near the corner of Dundas and Lyle streets. P. C. Woolway testified that he had known the defendant for some time, and he had seen him throw the stones. Deardon admitted having been in the crowd on the afternoon in question, but swore most positively that he had not thrown a stone or any other missile during the day. He had gone to the corner of Dundas and Lyle streets, because of a rumor that the non-union men would go on strike at 2:30 in the

"Never," was the reply. Mr. Magee looked puzzled, and having no other witnesses ready, the case

came to a standstill. Mr. Judd, for the defense, asked that the hearing be made a trial, the defendant having been put on the stand upon that understanding. The magistrate was disposed to agree, but Mr. Magee objected, and the magistrate discharged the defendant upon the examination, remarking that his story had been very straightforward, and it might easily have been a case of mistaken identity on the part of P. C.

Woolway. Horace L. Lamotte was up on a similar charge. P. C. Black testified that he saw him throw one stone and break a car window. P. C. Woolway testifled to having seen the defendant throw three stones, one at one car and two at another, from the corner of Dundas and Adelaide streets. There were only about a dozen people around at the time, which was 3:10 p.m. He had not attempted to arrest Lamotte, preferring to summons him. Lamotte was committed for trial at the assizes, bail being fixed at \$400.

A rioting case against George Terry was enlarged till Thursday. Isaac Downey was charged by P. C. McDonald with having thrown stone at a car on Dundas street at about 6:30 p.m. Downey claimed to have been on the opposite side of the street at the time with his wife and child. He denied having thrown anything. He was committed for trial. Bail was fixed at \$400.

Elizabeth Black, a semi-occasional visitor to the police court, arrested for being drunk, was discharged. Mary Wilkinson, examined for insanity, was committed to the asylum. Cases against John Pendergast, O. M. Finch and A. Borland, for not having

dispersed when ordered to do so, af-

ter the riot act was read, were enlarg-

ed till next Monday.

### STRUCK A TALLY-HO

Party of Excursionist Run Into by a Locomotive-Five Killed and Six Injured.
