Leader of Progressive Party Replies To Recent Attacks of Government Head-Wants To Know Administration's Stand If Reciprocity Proposals Are Revived.

Prince Albert, Sask., Nov. 5.—Launching into an explanation of the principles of the new national policy, the Hon. T. A. Crerar, leader of the Progressive party in Canada, last night criticised Premier Meighen for statements made in the premier's speeches at Truro, Sherbrooke and Grandby recently, in which Mr. Meighen had referred to "dangerous dectrines taught by dangerous men," "the extreme farmers' free trade party, etc.

Mr. Crerar quoted excerpts from the Canadian press reports of Melghen's speeches, and asked: "Is this the type of new statesmanship we are going to have in Canada?" He charged the premier with "misrepresenting, wilfully or not, people who were as loyal as any citizens in this country.

He declared the present government was allied with the big interests, and that what Canada needed was honesty in administration, equality in education, and toleration for the whole of the people of Canada

Exclusive of the eight undetermined seats in the Lower House, the Republicans had 286 members to 137 Democrats and four of other designations, a plurality of 149—the greatest ever held by any party in the House. The nearest approach to it was in the fifty-second congress, when the Democrats had a lead of 148.

Republicans appeared to be assured of better than an even break on the eight outstanding seats which would give them a record party margin in the them a record party margin in the House. The seats still in doubt were the fourth Maryland districts, first Minnesota, fifth Missouri, 15th, 21st and 23rd New York, 1st North Dakota and 5th West Virginia. ANOTHER APPEAL EXPECTED. [Special To The Advertiser.] Ottawa, Nov. 5.—In spite of the spectacular burst in sugar prices recorded this morning Ottawa does not believe that it has yet heard the last word from the sugar refiners. When Premier Meighen left for the west and

When Premier Meighen left for the west and Sir Henry Drayton for the east, the case of the refiners was left hanging in the air, and a definite answer has not been given them. The present slash in prices represents just about the margin of decrease which the sugar men represented to the Government at the privy council hearing would spell ruin to some and serious loss to all.



Sir Auckland Geddes, in Address Before Chamber of Commerce Members at Minneapolis, Points Out Necessity of Maintaining Cordial Trade Relations With U.S. and All Other Nations.

Minneapolis, Nov. 5.—"Great Britain and the United States must avoid national trade competition organized by governmental and supported by political action." Sir Auckland Geddes, British ambassador to the United States, declared today in an address at a chamber of commerce luncheon here.

If the United States or Great Britain, he said, are to begin to organize areas of exclusive economic advantage, there inevitably would come a clash of interests that would at least strain the friendly relations between the countries.

Sir Auckland denied statements appearing in United States newspapers that United States ships had been placed at a disadvantage with British ships by British Government action. He declared, however, not "in any sense as a threat, however veiled, but as a matter of interest," that if the British Empire should adopt a law precisely similar to the United States law limiting coastwise traffic to ships flying only its own flag, there would be some far-reaching derangements in the business of non-British shipping.
