To Basic Training Centres in their own Districts; if accommodation insufficient, to Basic Training Centres in other Districts within the same pool; if accommodation still insufficient, transfers of recruits between pools will be arranged.

(iii) The priority of disposal of trained reinforcements available for the next draft will be as follows: to fill vacancies on T.C. Instructional Staffs, to complete the Staff of an Infantry Holding Unit Overseas, and to fill vacancies in Units proceeding Overseas on the next draft. Ordnance reinforcements are not involved in this priority arrangement and will fill Overseas requirements.

(iv) C.A.C. Reinforcements in the Training Centres at Camp Borden will be posted, on completion of their training, to fill vacancies in the 5th (Armoured) Division.

(c) Veterans Guard of Canada

Selected personnel for the General Duty Company, V.G. of C., arrived at Lansdowne Park, Ottawa, for training prior to their early despatch Overseas for duty at Canadian Military Headquarters.
