Resolved, That a Committee of five members be appointed to provide Stationery for the use of the House.

Ordered, That the Hon. Mr. Wightman, Hon. Mr. Haviland, Hon. Mr. Lord, Mr. Laird and Mr. Macgill do compose the said Committee.

Resolved, That a Committee of five Members be appointed, to whom shall be referred every Private Bill, to report thereon.

Ordered, That Mr. H. Haviland, Hon. Mr. Palmer, Mr. Dingwell, Hon. Mr. Lord and Mr. Perry, do compose the said Committee.

Resolved, that a Committee of six Members be appointed to keep up a good correspondence between the two Branches of the Legislature, and to report their proceedings from time to time—with power to send for persons, papers and records.

Ordered, That the Hon. Mr. Wightman, Hon. Mr. Haviland, Hon. Mr. Longworth, Mr. Macdonald, Mr. Macgill and Mr. Mr. Munro do compose the said Committee.

Ordered, That the said Resolution be communicated by Message to the Legislative Council.

Ordered, That the Hon. Mr. Wightman do carry the said Message to the Council.

Resolved, That a Committee of five Members be appointed to prepare and report Standing

Rules and Orders for the governance of this House.

Ordered, That Mr. Macdonald, Hon. Mr. Lord, Hon. Mr. Montgomery, Hon. Mr. Wightman and Hon. Mr. Palmer, do compose the said Committee.

The Hon. Mr. Lord moved that Dennis O'Meara Reddin, Esquire, be appointed Law Clerk to this House.

The Hon. Mr. Palmer moved in amendment to the motion, to leave out the words "Dennis O'Meara Reddin," and substitute "John Longworth."
