Many Sick Soldiers Die on Their Way Home.

Shafter Says He Has Troops Enough in Santiago.

DIED ON THE WAY HOME.

New York, Aug. 20 .- The United States hospital steamer Relief arrived here this afternoon from Porto Rico, having on board 248 sick and wounded soldiers from Gen. Miles' army. Ten deaths from typhoid fever occurred on the voyage. Four other deaths from typhoid fever occurred on the Relief The Relief also brought twenty wounded men, including three officers, the most of whom were shot in the battle near Mayaguez on Aug. 10. The total number of cases of typhoid fever on

the Relief was 167. Capt. Arthur Lee, British military attache, was a passenger on the United States hospital steamer Relief, which arrived here yesterday afternoon from Porto Rico. Capt. Lee is suffering from intermittent malarial

fever. TROOPS ENOUGH IN SANTIAGO. Washington, Aug. 20 .- Gen. Shafter has informed the war department that after consulting with Gen. Lawton, commanding the department of Santiago, it will not be necessary to send any more troops to preserve peace and

good order. The naval base has been changed from Key West to Norfolk, and all the vessels at the former place have been ordered north. The appearance of ten cases of yellow fever caused this order

to be issued. Four thousand Spanish troops have already been shipped from Santiago, and the transports Villa Donga and Estrada Panai will leave today with 3,000 more. Six thousand Spaniards at Guantanamo Bay cannot leave before the last of the month. Sickness is inereasing among them.

THE CUBAN DEBT. Madrid, Aug. 20 .- It is rumored that the government will instruct the Cuban commissioners to present a strong case for the recognition of Spain's claim for compensation for the cession of public works in Cuba, the compensation to take the form of saddling upexisting in 1895. The papers advocate the strengthening of Ceuta and Andalusian ports in anticipation of Anglo-

CATHOLIC CHURCH PROPERTY. Chicago, Aug. 20.-A special from Manila says: All church property in Manila has been deeded, for the consideration of \$1, to Cardinal Gibbons, of Baltimore.

The Archbishop of Manila declares himself as having desired peace from the beginning of the war. He denies the authorship of the proclamation attributed to him. The Dominican friars have offered a church to Father Ready, chaplain of the Olympia.

SAGASTA ON THE SITUATION. Madrid, Aug. 20 .- El Liberal publishes remarks made by Senor Sagasta on the diplomatic and positical situation quoting the premier as follows: From a legal point of view, the present state of things is neither peace nor war, but merely a suspension of hostilities. An armistice would have allowed us to dispel better the obscurity of the sit-uation, but the United States declined to agree to our making a step further

The questions to be solved are numerous and complex. What we have done first is to lay down certain bases of which each minister may make any observations which study of the subject suggests. These will continue to be treated in daily cabinet councils, it being held that the bases in question are fundamental instructions for the guidance of the various commisin the forthcoming negotiations, to be supplemented and rectified sub-

sequently by telegraph. In Cuba, besides evacuation, there are many other problems. Spain may atandon her sovereignty over the Greater Antilles, but there will remain the question of edifices and all our properties. There are law suits before the tribunals affecting the interests of Spaniards. Where and when will these be decided? In Havana, where a large number of criminals have been condemned by Spanish tribunals, what is to be done with them?. Then there are other questions for which we have to fix a basis of discussion and agreement, regarding the Philippines. > Chicago, Aug. 20.-The Chicago board ternational convention to settle disputed points between the United States and Canada will begin its session at Quebec on Aug. 23, and it is proposed to have a strong petition from the Chicago Board of Trade and other commercial interests before the convention. It is urged that the removal of the canal tolls will result in greatly increasing the business from the west to Montreal for export, and that the Canadians will gain in the increased traffic much more than they will lose by the abolishment of the tolls, which am-

ount to half a cent per bushel. The change would be of great advantage to the smaller class of vessels, both American and Canadian, which have been forced down to star-vation rates by the construction of the large carriers the past few years. The big fellows are shut out from Welland Canal trade, and the smaller boats would have the field to them-selves. Millions of dollars' worth of vessel property would be greatly enhanced in value by the removal of tolls in this way.

Hundreds of Thousands of Wildly En thusiastic Citizens Take Part-A Grand Pageant.

New York, Aug. 20.-The reception given to Admiral Sampson's squadron by the people of Greater New York today was a magnificent one, and was Long before the sunrise gun was fired at Governor's Island the people were astir and about. Crowds were hurrying to the river to be early on the scene. Long before the time when the ferry boats and street cars are usually crowded, great throngs of people hung on the straps, trod on each other's feet, and journeyed in con-veyances to points along the river front. The New York and New Jersey shores were literally black with people, while the river and bay were thronged with craft, and the craft alive with people, all cheering and good-natured.

There was very little friction in the carrying out of the programme, and no delay. The citizens' committee left the foot of Cortland street on the steamer Glen Island at an early hour, and proceeded down the bay, followed by a long retinue of all sorts and descriptions of craft. At Tompkinsville, the mayor and committee embarked on the flagship New York. The welome ceremonies were short but impressive. The ceremonies over, amid the shrieking of steam whistles and the cheers of the throngs, the mayor and the committee returned to the Gen Island. Then came

THE EVENT OF THE DAY. There was considerable wigwagging on the gray batttleships and then the police boats formed in line, and the battleships, at 10:10 a.m., began to slowly move up the bay. PIONEER GONE

Ex-Sheriff Gibbons Death of Goderich.

Goderich, Ont., Aug. 20. - Robert Gibbons, ex-sheriff, died last evening, aged 87 years. Mr. Gibbons was born in Glasgow. He emigrated to Canada in 1832, coming to Goderich, then a village of less than 250 inhabitants Here he launched into business, and at an early age took a leading part in municipal affairs, subsequently serving several terms as mayor of Goderich, and was for many years reeve and warden of the county. Mr. Gibbons was elected to represent South Huron in the parliament of Ontario, and four years later, in 1871, was re-elected to the legislature, each time as the candidate of the Liberal party. After serving during two terms of the parliament, Mr. Gibbons resigned his seat to accept the shrievalty of Huron county, which office he filled until about a year ago, when advancing age compelled him to retire to private

His Cousins and His Aunts. Mayence, Hesse, Aug. 20 .- Emperor William, accompanied by the Grand Duke of Hesse, arrived here at 6:40 a.m. to day to attend the review. It is his first visit to the city since his accession. Mayence is en fete and brilliantly decorated. On leaving the train the emperor proceeded on horseback to a triumphai arch at the castle gate, where the chief burgomaster delivered an address of welcome to his Majesty. Emperor William replying to the address, said: "I thank you, worshipful burgomaster, for your cordial words. L am not a stranger to your city. When here as a boy I conceived ideas similar to those you have just expressed. The holy Roman empire of German peoples tell because it was not built on a national foundation, Its decadence was due to lack of patriot-ism and cohesion. The German em pire of today arose out of a strongly felt need of union and of common head, and it reared itself upon the
