HOUSE OF COMMONS.

THURSDAY, March 12, 1903.

The Parliament, which had been prorogued from time to time, was now commanded to assemble on the 12th day of March, 1903, for the despatch of business.

The SPEAKER took the Chair at Three o'clock.

A Message was delivered by Molyneux St. John, Esquire, Gentleman Usher of the Black Rod :

Mr. SPEAKER,—I am commanded to inform you that His Excellency the Governor General desires and awaits the attendance of your honourable House in the Senate Chamber.

Accordingly the House went into the Senate Chamber.

THE CLERK OF THE HOUSE.

Mr. SPEAKER. I have the honour to inform the House that Mr. Thomas Barnard Flint, Esquire, has been appointed Clerk of the House, in place of Sir John Bourinot, deceased.

ELECTION PETITIONS—JUDGMENTS OF SUPREME COURT.

Mr. SPEAKER. I have also the honour to inform the House that I have received from the Registrar of the Supreme Court of Canada, a certified copy of the judgment of the said court in the election appeal for the electoral district of Two Mountains, by which the judgment of the lower court declaring the election void, was affirmed.

In conformity with chapter 9, section 46, of the Revised Statutes, I issued my warrant to the Clerk of the Crown in Chancery to make out a new writ of election for the said electoral district.
