NATIONAL PARK, FORT LATOUR, SAINT JOHN, N.B.

Question No. 1,199-Mr. Bell:

With respect to the proposed national historic park at Fort LaTour, Portland point, Saint John, N.B. (a) what are the results of the excavations there of last summer (b) have any approaches been made in France regarding the early French records and, if so, with what results (c) what is the present government thinking as to participation?

Mr. Laing: (a) The archaeological excavation showed that not enough evidence of Fort LaTour survives to make an authentic reconstruction possible. Although various artifacts were found, only scattered and disconnected fragments of wall remain from the fort itself. (b) A search for documentary material relating to Fort LaTour was made in France last year and during the past winter, without any success. (c) The government is prepared to consider financial participation on an equal basis with the government of New Brunswick and the municipality in the acquisition of the property containing the site of Fort LaTour, if this is the wish of those two bodies, and a suggestion to this effect has been forwarded to the provincial government and the county of Saint John.
