> What the minister is really doing through these proposals is to follow his own profession. He wants to reduce Canadians to a nation of small, petty bookkeepers. Instead of energizing our human resources, he wants to engage us in the task of keeping the nation's books. > I should like to know who is going to pay for all the appraisers who will be required to evaluate property. > As the Leader of the Opposition said, nothing will give greater assistance to foreign powers to take over the capital resources of this nation than the capital gains tax that is suggested in this so-called white paper. As the minister knows, desire for monetary profit competes with other factors, such as preference for leisure and other pursuits. Work also entails fatigue and anxiety. Therefore, it follows that when monetary reward is lessened by taxation, personal situations must be reassessed.

This white paper will not be endorsed by members of our labour unions. Many workers in labour today earn up to \$10,000, even
