# CBC—"THE NOBLEST OF CALLINGS—THE VILEST OF TRADES" FILM

### Question No. 963-Mr. Robinson:

With regard to the film entitled "The Noblest of Callings-The Vilest of Trades", aired on CBC Wednesday, January 6, 1971, will the government advise (a) who chose the members appearing on the program (b) on what basis were they chosen (c) who edited the film (d) who edited the audio portion (e) did those appearing on the program receive any remuneration and, if so, how much (f) what was the total cost of the program (g) by whom was the cost borne (h) what was the cost of the Canadian portion (i) what was the cost of the British portion (j) what was the cost of the American portion (k) was the program shown in the United States and Britain as well as in Canada (1) was the film censored as to the use of profanity and vulgar language and, if not, for what reason (m) was any other film made on members other than those who appeared, that was not shown (n) will the film be shown again and, if so, where and on what date (o) are any future films of a similar nature contemplated and, if so, on what date and who will be the (p) is it proposed that the film will be shown in the United States and Great Britain or any other countries?

Hon. Gérard Pelletier (Secretary of State): I am informed by the Canadian Broadcasting Corporation as follows: (a) Members of Parliament appearing on the program were chosen by the producer in consultation with his associates. (b) Members were chosen in relation to the character and structure of the program, having in mind their representativeness as backbenchers and their willingness to cooperate in the production at all stages. (c) and (d) The producer and his associates edited the film and the audio portion. (e) to (j) No fees were paid to the Canadian political figures. Certain other participants re-

ceived fees, but it has not been customary to require the Corporation to disclose details of internal management and administration such as fees paid to participants in its programs and individual program costs. (k) No, but interest has been shown in the U.S. and U.K. for a showing. (l) Normal editing was carried out. (m) Yes, as often happens, some of the film shot was not used. (n) There are no present plans for further showings. (o) There are no present plans in this direction. (p) Refer to "k".

## CONTROL OF COMPANIES BY CAPE BRETON CORPORATION
