## CONSTITUTIONAL CONFERENCE

DISCUSSION OF OFFSHORE MINERAL RIGHTS AT VICTORIA

Mr. Elmer M. MacKay (Central Nova): I have a question I should like to direct to the right hon. Prime Minister. Was the important issue of offshore mineral rights one of the subjects discussed with the provinces at Victoria?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, the subject was raised but it was not brought to any conclusion at the discussions, as indeed was the case with many other subjects raised and which did not form the basis of what we call the charter.

Mr. John Lundrigan (Gander-Twillingate): Could I ask the right hon. Prime Minister whether there were any new proposals to the provinces regarding the sharing of revenues from offshore mineral and oil resources?

Mr. Trudeau: No, Mr. Speaker. We are still waiting for answers from the provinces to the plan we put to them more than a year ago.

PROPOSED AMENDMENTS TO SOCIAL SECURITY PROGRAM

At this conference, the federal Minister of National Health and Welfare did actually make some suggestions as to the ways the federal government could considerably improve, for instance, the family allowance program. He also submitted other proposals with respect to public assistance. But as I just told the Leader of the Opposition, I will have to discuss the matter with the minister concerned in order to determine whether he should make a statement to this effect within the next few days.
