POINT OF ORDER

MR. McGRATH—PUBLIC OPINION POLLS—REPLY OF MINISTER OF JUSTICE

Hon. James A. McGrath (St. John's East): Madam Speaker, I wish to raise a point of order arising out of a reply given today by the Minister of Justice (Mr. Chrétien) with respect to releasing certain polls that were commissioned by the government. My point of order is based on the means which the minister has adopted to get these polls out to members of Parliament. For example, he did not take advantage of Standing Order 41(2) which provides that any minister may lay upon the table of the House any document.

I may have a question of privilege, because if the minister had in fact laid the polls on the table of the House, we would have been in a position to make a judgment as to whether or not an advertisement which appeared last week in the *Financial Post* entitled "A Subscription to the Goldfarb Report" does in fact constitute a very serious breach of the privileges of this House. One section of this full-page advertisement reads:

In particular, the 1981 edition of The Goldfarb Report will include a detailed treatment of public attitudes toward the debate surrounding a new Canadian constitution.

It goes on to say where one may obtain the report. It would seem to me that up to this point what has been denied to the House is available through a professional consultant for a fee. This would seem to me to constitute a very serious breach of the privileges of every member of this House. I reserve the right to raise the matter later. • (1510)
