policy. Therefore I think his statement has all the more authority when he says that the economy has never been in better shape in the last 15 years.

I might advise my friend that I did not take a totally negative attitude to his question the other day. On the contrary, I indicated the large contribution the federal Government had brought to Prince Edward Island in helping that province reduce its dependence on oil in particular, especially in the area of conservation of energy generally, through home insulation, et cetera. Programs were specifically tailored for situations like that of Prince Edward Island.

As far as the report the Hon. Member has referred to is concerned, I will read it with interest, but I can tell him that the studies the Department of Energy had made at that time, in consultation with the Governments of New Brunswick and P.E.I., seem to indicate that the cost of not using the Lepreau electricity was much higher than if it had been used.

ENERGY SUBSIDY

Mr. Tom McMillan (Hillsborough): Mr. Speaker, the Minister will recognize that, while conservation is important, it is just the tip of the iceberg as far as Prince Edward Island's energy problem is concerned. Therefore, does he at least recognize that exorbitantly high electrical costs on the Island constitute the biggest obstacle to that province ever achieving any degree of economic self-sufficiency? If so, would he be prepared to recommend to the new Liberal Prime Minister after the weekend that he examine the idea of a P.E.I. energy subsidy with an open mind so that the Island can become more industrially competitive and ultimately less dependent on transfer payments both to individuals and to the Government?

Hon. Marc Lalonde (Minister of Finance): Mr. Speaker, I do not agree with the analysis of the Hon. Member. I can only remind him that the federal Government paid \$18 million, I believe, for an electrical transmission cable to Prince Edward Island. That is a significant subsidy to help reduce the cost of electricity to the people of Prince Edward Island.

LAY-OFFS AT WOODS INCORPORATED, TORONTO

Ms. Lynn McDonald (Broadview-Greenwood): Mr. Speaker, my question is directed to the Minister of Supply and Services concerning another plant closing, Woods Incorporated, in my constituency. Some 140 production workers have been laid off, and the question is whether it is temporary or permanent. The Minister will know the company because it bid successfully on a number of contracts before, and has recently bid on a major contract. Can the Minister hold out any hope for those workers who have been laid off that there will be production jobs in September and that they will be getting back to work?

SLEEPING BAG CONTRACT
