### REPORT OF CANADIAN PARLIAMENTARY DELEGATION TO INDIGENOUS PARLIAMENT FOR THE AMERICAS

Mr. Willie Littlechild (Wetaskiwin): Mr. Speaker, I am pleased to present, in both official languages, the report of the Canadian parliamentary delegation which attended the fourth meeting of the Indigenous Parliament for the Americas in Guatemala City from October 8 to October 12, 1990. This was an international meeting of indigenous members of Parliament which provided an opportunity for parliamentarians to meet on matters of common interest.

Four major topics were discussed this year, including the desire of indigenous peoples to become more involved in environmental matters, in particular the UN conference scheduled for Brazil in 1992.

Other resolutions concerned the ILO Convention 169, human rights violations and the fifth centenary commemoration for 1492.

I am also pleased to report that Canada will be host to the fifth meeting of this parliament.
