PROPOSED REFERENCE TO COMMITTEE OF ALLEGEDLY ILLEGAL INTERCEPTION OF MAIL—MOTION UNDER S.O. 43

Mr. Bill Jarvis (Perth-Wilmot): Mr. Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity. Having regard to the serious doubts now raised publicly about the integrity, or lack thereof, in the Solicitor General's annual report to parliament dated February 11, 1977 wherein it was asserted that only one warrant authorizing postal communication interception was issued in 1976, which warrant allegedly could not be executed, and since it is now alleged in media reports that mail interception with or without warrant may have been, and may be, a common occurrence, I ask leave to move, seconded by the hon. member for Brandon-Souris (Mr. Dinsdale):

That a reference be made to the standing committee on Justice and Legal Affairs to permit that committee to investigate in its entirety the matter of illegal and unauthorized interceptions of mail.

Mr. Speaker: Under the terms of Standing Order 43 such a motion can be put to the House only by unanimous consent. Is there unanimous consent?

SUGGESTED DELAY OF TARIFF REDUCTIONS PENDING INTRODUCTION OF INDUSTRIAL STRATEGY—MOTION UNDER S.O. 43
