SALK VACCINE-ALLEGED CONTRACTION OF DISEASE AFTER VACCINATION

On the orders of the day:

Mr. G. S. White (Hastings-Frontenac): I should like to address a question to the Minister of National Health and Welfare. Is the minister in a position to comment on the correctness of a report in the press that a child in the village of Stirling had contracted polio after being inoculated with Salk vaccine?

Hon. Paul Martin (Minister of National Health and Welfare): I am in a position to say that the report of yesterday that a child in the constituency of my hon. friend had contracted polio after having been inoculated three times with Salk vaccine is now followed by a report this morning that the child is up again. Physicians say that the child did not have polio. We are in the fortunate position in this country of having immunizations of close to one million, and not having had one mishap.

SUMMER MONTHS

On the orders of the day:

Mr. W. B. Nesbitt (Oxford): I should like to ask the minister a question along similar lines. In view of press reports in the Montreal Gazette that the Salk vaccine program is to be suspended for July and August, can the minister tell us whether or not children who have received the first shot of vaccine will be able to receive the remaining two shots during July and August? If not, is there any chance that the effect of the first shot will be lost before the remaining shots of vaccine are given? I ask this question as it is my understanding that when a series of shots of vaccine are given to immunize persons against other diseases, they have to be given during a definite period of time.

Hon. Paul Martin (Minister of National Health and Welfare): My hon. friend will undertand that I proceed entirely on the scientific opinion of those who are trained in this field. All those who have been immunized this year have received at least two shots. The provinces, in collaboration with the federal government, have decided that in view of the uncertainty that exists as to the desirability of vaccinations during the summer months it would be prudent not to proceed with the program during July and August. This is not really a new decision. This is a decision that was arrived at almost a year ago. There is no suspension of the program. The program is being carried out in accordance with an arrangement we made a year ago.
