### CANADIAN WHEAT BOARD ACT

PROVISION OF SEPARATE ACCOUNTS FOR TYPES OF WHEAT

Mr. A. B. Douglas (Assiniboia) moved for leave to introduce Bill C-208, to amend the Canadian Wheat Board Act.

Some hon. Members: Explain.

Mr. Douglas: Mr. Speaker, the Canadian Wheat Board Act authorizes separate accounts or pools for wheat, oats and barley. However, there are four distinct types of western Canadian wheat, namely, hard red spring wheat, hard red winter wheat, soft white spring wheat and Durum wheat.

These four types of wheat are as different from each other as are oats and barley. Therefore it is in the interests of equity that the producers of these various types of wheat be dealt with separately, which is the purpose this bill is intended to achieve.

Motion agreed to, bill read the first time and ordered to be printed.
