## BUSINESS OF SUPPLY

ALLOTTED DAY, S.O. 58-ALLEGED FAILURE TO PROTECT PUBLIC TREASURY IN REFIT-TING OF HMCS "BONAVENTURE" AND GEN-ERALLY

Mr. Thomas M. Bell (Saint John-Lancaster) moved:

That the government has displayed its mismanagement and abuse of powers and has failed in its responsibility to protect the public treasury in relation to the refitting of H.M.C.S. Bonaventure in particular; and generally there has been neglect and default in carrying out programs and recommendations designed to protect the taxpayers of Canada from waste, extravagance and other abuses in the spending of government money and for these failures the government deserves the con-demnation of the House.

He said: Mr. Speaker, we have had a long afternoon of questions of privilege, statements and the like, and even though the hour is late I hope that this motion will commend itself to the members of the House. It may receive a mixed reaction from some, but I think all members on the treasury benches will welcome an opportunity to put their side of the case concerning the Bonaventure before the House and on the record. Personally, as a member of parliament, I feel that I have a grave responsibility to bring this matter forward for discussion, and I am more than pleased that my colleagues have agreed that it should be the basis for an opposition motion on an allotted day.

I never thought that the time would come, Mr. Speaker, when I would feel sorry for a civil servant. But I must admit I do now, because I feel that many of the civil servants who have been involved in the Bonaventure fiasco should have their day in court. I firmly believe that it can only be here, in this forum, which is the highest court in the land.

There are, as I see it, two general responsibilities with regard to the Bonaventure, and both are interrelated. I have arbitrarily called them the financial responsibility and the political responsibility. I think the financial responsibility has been dealt with quite well.
