#### STATUTORY INSTRUMENTS

NATURE OF CABINET DIRECTIVE RESPECTING DEPARTMENTAL GUIDELINES

Mr. Douglas A. Hogarth (New Westminster): Mr. Speaker, I wish to direct a question to the Minister of Justice with respect to the implementation of the third report of the Special Committee on Statutory Instruments. Would the minister advise the House whether the cabinet directive referred to by his predecessor relating to departmental directives and guidelines has been issued and, if so, would he advise the House of the nature of that directive?

Hon. Otto E. Lang (Minister of Justice): Yes, Mr. Speaker. The cabinet has directed that all directives or guidelines are to be submitted to the Deputy Minister of Justice, who will advise the issuing authority whether they are in conflict with any provision of the act or the regulations to which they relate, whether they are essentially legislative in nature, whether their subject matter should be incorporated in regulations and, if so, whether there is authority to make such regulations.
