2. These men had a number of personal items with them when they left Canada. Their suitcases were locked in an immigration baggage room at Toronto International Airport and the location of the key for that room was unknown to the immigration officers who were on duty at the airport at the time deportation was carried out. Their suitcases did not accompany these men on their departure.

SUMMER EMPLOYMENT—PORT OF LANSDOWNE, ONTARIO Question No. 2,082—Mr. Cossitt:

- 1. What were the names and addresses of all those persons who applied for summer employment with both Canada Customs and Canadian Immigration at the Port of Lansdowne, Ontario?
- 2. How many of these persons were called in for an interview and on what basis was the list of persons to be interviewed selected and by whom?
- 3. What were the names of all those who were eventually given summer employment?

Mr. John M. Reid (Parliamentary Secretary to President of the Privy Council): I am informed by the Departments of Manpower and Immigration and National Revenue as follows: 1. The names and addresses of all persons who applied for summer employment with Customs and Excise at the Port of Lansdowne, Ontario, are in the custody of the Canada Manpower Centres at Brockville and Gananoque. The Public Service Employment Act precludes divulging the names and addresses of candidates for positions. However, of all the applications for summer employment received at the Gananoque and Brockville CMCs this year, six specified a preference for employment at the port of Lansdowne. As there was no requirement for summer assistance at the Canada Immigration Centre at the port of Lansdowne this year, all applications were referred for consideration to Canada Customs.

2. The port of Lansdowne employs 30 seasonal officers during the summer months. This year 22 students returned from previous years. For the remaining eight positions, 29 applicants were referred by the Canada Manpower Centre for interview on the basis of "Procedures To Be Followed for the Canada Manpower Centre in the Recruitment, Referral and Selection for Non-Career Oriented Summer Employment" which are issued by Public Service Canada.

Consideration was given by both the Ontario Region of the Unemployment Insurance Commission and subsequently by the Head Office to the opening of a full time office in Smiths Falls, Ontario; (a) this study took place during 1972, when the whole concept of decentralization was being considered; (b) Not applicable.

2. At the present time the clients in this area are served from the Ottawa District Office on an itinerant basis of three days per week. Of the total claimants served by the District Office there are approximately 400 residing in the Smiths Falls area. Due to this minimum number of clients, the present services are considered adequate. These services will be subject to a continuous analysis to determine if any change is required.
