## DAY CARE

PROVISION OF SERVICES—GOVERNMENT POSITION

Mrs. Lucie Pépin (Outremont): Mr. Speaker, I have a question for the Minister responsible for the status of women. In her absence, I direct it to the Prime Minister. During the election campaign two years ago the Conservative Party singled out day-care services as a priority. The Speech from the Throne makes reference to launching discussions between the Governments of the various provinces, the private sector and the unions. Mr. Speaker, can the Prime Minister tell us

when these endless discussions will stop and when his Government will take action concerning day-care services? What kind of concrete action does he intend to take and when?

Mr. Speaker, the Government has turned to concrete action.

Mr. Broadbent: Just turned to concrete.

Mr. Epp (Provencher): During the election campaign the Prime Minister made two commitments on child care. One was a task force, not on whether but on how to best implement it. The Hon. Member has been sitting on this task force. We expect that report at approximately the end of November.

Second, in this Throne Speech the Prime Minister has clearly indicated that he is now moving from that commitment to the next commitment of implementation. The Hon. Member surely recognizes that there are a number of partners in the relationship for the provision of child care. We hope she will support the Prime Minister and the Government on the actions that have been taken.
