**Exchange Bank** :—Motion proposed by Sir Richard Cartwright on the subject of advances made to the Exchange Bank of Canada, etc.; Debate arising thereon; adjourned; and question fixed as First Order of the Day on a future day, 227. Motion negatived, 254.

**Exhibition, Colonial and Indian :**

1. Motion proposed by Mr. Pope, for the House to go into Committee to consider certain Resolutions relative to a guarantee on the part of Canada against any loss resulting from the Exhibition to the extent of £10,000 sterling, etc.; His Excellency's consent signified, etc., 278. In Committee; Resolutions adopted, 399. Reported and agreed to, 444.
2. Bill (No. 126) to provide for the fitting representation of Canada at the Colonial and Indian Exhibition to be held in London in 1886; presented: Mr. Pope, 444. Read second time; considered in Committee; reported; read third time; passed, 632. Passed by the Senate, 691. Royal Assent, 950.—48-49 Victoria, Chapter 44.
