"continue to hold office until the expiry of the term for which he has been elected and to be a member of the said Senate, notwithstanding that, being a member of the Senate elected thereto by the General Assembly, the term for which he was so elected may have expired and he has not been re-elected by the said General Assembly. And in the event of the Vice-Chancellor dying, resigning, or ceasing to be a minister, elder or member of the said Church, as the case may be, then the Senate shall proceed to elect another of their own number as a Vice-Chancellor for the remainder then unexpired of the term for which the Vice-Chancellor so dying, or resigning, or ceasing to be a minister, elder or member of the Church had been elected.

"8. The Senate shall have the power to confer the Degree of Bachelor in "Divinity, after examination, upon students who shall have completed the regular "course in Theology, in such of the Theological Colleges or Halls under the care "of the said General Assembly, as may enter into affiliation with the said University, or upon any Minister or Licentiate of the Presbyterian Church in Canada, "or upon such others as the Senate may from time to time by any By-law in that "behalf admit to compete for the Degrees, provided always that the Degree of Bachelor in Divinity shall not be conferred, unless the candidate has previously graduated in Arts in some University in the Dominion of Canada, or in Great "Britain, or Ireland, or in some other University approved of by the Senate; and "the Senate may also confer the Degree of Doctor in Divinity upon such persons "as, on account of distinguished merit and eminent Theological attainments, it "may deem entitled to the said honour.

"9. The Senate shall have power from time to time to make and alter any By"laws and regulations (not being repugnant to any law in force in

"Houours, and Scholarships, and the granting of the same and charging reason"able fees in that behalf; also the appointment and duties of Examiners and the
"course of study to be pursued; also as to the quorum of the Senate, the time and
"mode of summoning the meetings thereof, and generally respecting all other
"matters for promoting the purposes of the University, or for carrying into effect
"the intent and spirit of this Act, and all such By-laws and regulations, when re"duced into writing and under the common seal of the University, shall be held
"to be binding on all persons, members thereof, and upon all candidates for De"grees, Honours, or Scholarships, and upon all others whom this may concern.

"10. The Senate shall also have power and authority to pass By-laws and "regulations, defining the terms upon which the Theological Colleges or Halls "under the care of the General Assembly may affiliate with the said University, "provided that no By-law or regulation, passed under this Section, shall take "effect until the same has been submitted to and receive the sanction of the said "General Assembly.

"11. The Senate shall have the management of and the superintendence over "the affairs, concerns, and property of the University, and shall have full power "to invest the moneys from time to time belonging to the University for the purposes thereof, or upon any special trusts connected therewith in the public securities of the purposes of the securities of the securitie

"Whereupon, it was moved by Professor McLaren and seconded by Principal McVicar, That the report be received, adopted and submitted to the General Assembly as the judgment of the Committee. It was moved in amendment by Hon. A. Morris and seconded by Mr. T. W. Taylor, That, inasmuch as two modes have been proposed for the establishment of a joint authority for the conferring of Degrees in Theology—the one, the creation by Act of Parliament of a University in connection with the Church, designed to effect this end, and the other, the accomplishing a like object, by an adaptation of the powers now existing in the University of Queen's College under the Royal Charter—the Committee recommend the Assembly to re-appoint the Committee to consider the whole subject maturely and report to the next General Assembly."

"The motion was carried by the vote of the Convouer."
