PROPOSED FEASIBILITY STUDIES FOR NEW COAL MINES IN NOVA SCOTIA—MOTION UNDER S.O. 43

Mr. Andy Hogan (Cape Breton-East Richmond): Mr. Speaker, I rise under Standing Order 43 on a matter of urgent and pressing necessity. Since a privately financed international study group which included Canada's National Energy Board Chairman, Marshall Crowe, and Maurice Strong, Chairman of Petro-Canada, Canada's national oil company, who both were involved in this study, that study predicting that demand for oil in the non-communist world will probably overtake available supplies some time between 1985 and 1995, and possibly by 1981; since electricity costs in Nova Scotia, a province which is a large importer of oil, have increased about 100 per cent over a two year period; and since in April there were 14,476 active claimants on the unemployment insurance rolls in Cape Breton, and some 3,500 applications for jobs in the Cape Breton coal mines, I move, seconded by the hon. member for Winnipeg North Centre (Mr. Knowles):

That the Department of Regional Economic Expansion, along with Devco, immediately start feasibility studies for new mines in Donkin and New Victoria in Cape Breton county.
