

DECISIONS RENDERED BY GRAND MASTER.

PHYSICAL QUALIFICATION.—There is nothing in the constitution or landmarks for disqualifying a hunchback from being initiated into Masonry, provided he could comply with all the ceremonies of the initiated in the several degrees.—(Proceedings, May, 1877).

LODGE BUSINESS.—It is not competent for a Subordinate Lodge at an emergent meeting to enter on any other business than that specified on the summons.—(Proceedings, 1887).

RESTORATION.—A brother who has been indefinitely suspended, can be restored to membership by a majority vote of the Lodge at any regular communication, notice having been given at a previous regular communication, that a motion to that effect would be made.—(Proceedings, 1880).

MASONIC BURIAL.—The friends of a brother who died while under suspension for non-payment of dues, cannot by paying his dues, entitle him to Masonic burial.—(Proceedings, 1880).

MOTIONS.—A brother who gives notice of motion to amend the Constitution cannot delegate another brother to move in the matter in his absence.—(Proceedings, 1880).

Demits cannot be granted to Entered Apprentices and Fellow Crafts, 1885.

Lodge working U. D. cannot affiliate brethren, 1885.

DEMIT.—A vote of the Lodge is the demit, the paper the evidence thereof.

ALTERATION OF THE CONSTITUTION.—Section 14 of the By-Laws as amended to read :

The Officers of a Subordinate Lodge shall be installed on the 27th day of December, or as soon thereafter as practicable, but not later than the Regular Communication in January.
