## ASSOCIATION OF UNIVERSITIES AND COLLEGES OF CANADA

The house in committee on Bill No. S-36, to incorporate Association of Universities and Colleges of Canada-Miss Jewett-Mr. Lamoureux in the chair.

On clause 1-Incorporation.

Mr. Webster: Mr. Chairman, the present widespread and practical interest in higher education has been expressed in many ways. One of the most obvious ways has been the co-operative efforts of the universities themselves through two organizations, the national conference of Canadian universities and colleges and the Canadian universities foundation. This bill simply brings together these two bodies into a single organization for greater efficiency. It is a tidying up process. This organization will serve two purposes. It will serve as an agency for the distribution that function. It will not have any additional of federal grants to universities, and it will provide a medium through which universities and colleges can communicate and cooperate in advancing the interests of higher education. We are pleased to support the per capita grants which are already distribbill.

Mr. Grégoire: Mr. Chairman, I only wish to direct a question to the hon, member who acts as sponsor of this bill.

Can the hon. member tell us whether, as incorporated, the association of universities and colleges of Canada will be in a position to ask for federal grants to assist universities and colleges?

Miss Jewett: Mr. Chairman, this association will operate in this respect in the same way that the association it replaces operated. That is to say, it will act to some extent as the liaison between the universities and the government wherever such liaison is necessary. It will act as spokesman for the universities on whatever matters the universities require a spokesman vis-à-vis the government. If that includes financial matters I assume it will speak on those matters as well as others.

Will one of the objects of this association of universities and colleges of Canada be to obtain federal grants for the association members, that is the colleges and universities belonging to it?

Miss Jewett: It will distribute federal grants just as the Canadian universities foundation does now.

Mr. Grégoire: Mr. Chairman, today the Canadian universities and classical colleges foundation gets its grants through the Canada Council.

Will the new association have the privilege to get directly from the federal government grants that it would hand over afterwards to colleges and universities?

Miss Jewett: My understanding is that the Canadian universities foundation now distributes what it calls the per capita grants. It is the agency in this country for the distribution of these grants. Under the new legislation the new association will take over function. In other words, there will not be, unless the parliament of this country so desires, any other grants to be distributed through this new association, apart from the uted through its predecessor.
