BILL.

An Act to incorporate the "Bank of Brantford."

WHEREAS John Aston Wilkes, Abraham Cook, Allen Good, Preamble. George Samuel Wilkes, Henry Yardington, Charles Whitlaw, P. C. VanBrocklin, and others, have by their petition prayed, that they and their legal representatives might be incorporated for the purpose of establishing a Bank in the Town of Brantford; And whereas it is expedient to grant the same; Therefore Her Majesty, &c., enacts as follows :

I. The several persons hereinbefore named, and such other persons as Certain permay become Shareholders in the Company to be by this Act created, sons incorpo-In and their assigns, shall be and they are hereby created, constituted and declared to be a Corporation, body corporate and politic, by the name of the "Bank of Brantford," and shall continue such Corporation, and shall Corporate have perpetual succession and a Corporate Seal, with power to alter and name and genchange the same at pleasure, and may sue and be sued, implead or be

- 15 impleaded in all Courts of Law as other Corporations may do, and shall have the power to acquire and hold real and immoveable estate for the Real property management of their business, not exceeding the yearly value of two limited. thousand pounds currency, and may sell, alienate or exchange the same, and acquire other instead, and may, when duly organized as hereinafter May make By-
- n provided, make, ordain and establish such Rules, Regulations, and laws. By-laws as to them shall seem meet and necessary for the due and proper administration of their affairs, and the due management of the said Bank, such By-laws, Rules, and Regulations not being inconsistent with this Act, or contrary to the laws of this Province; Provided, however, that Proviso.

such Rules, Regulations and By-laws shall be submitted for approval to the Stockholders or Shareholders in the said Bank, at their regular Annual Meetings.

II. The Capital Stock of the said Bank hereby incorporated shall be Capital two hundred and fifty thousand pounds, current money of this Province, shares of £250,000 in odivided into ten thousand shares of twenty-five pounds currency each, each. which said shares shall be and are hereby vested in the several persons who shall subscribe for the same, their legal representatives and assigns.

III. For the purpose of raising the amount of the said Capital Stock, Stock books it shall be lawful for the persons hereby incorporated, or for any number may be openb of them not less than five, to cause Stock Books to be opened, after ed. giving four weeks' public notice in two newspapers in the County of Brant, upon which Stock Books shall and may be received, the signatures and subscriptions of such persons or parties as desire to become Shareholders in the said Bank, and such Books shall be opened at Brantford At Brantford and elsewhere, at the discretion of the persons opening the same, and
