

Resolved that the sum of £200 be granted to the Rector, Church-Wardens and Vestry of Saint Andrew's Church, in the Parish of Saint Andrews, towards lengthening and repairing the said Church.

Resolved that a sum not exceeding £100 be paid to such Commissioners as His HONOR the PRESIDENT shall appoint, for the purpose of hiring for five years a suitable situation in the City of Saint John, or in its vicinity, for the accommodation of the Commander-in-Chief for the time being, when he may have occasion to visit that City.

Resolved that the sum of £150 be granted to the Rector, Church-Wardens and Vestry of the Parish of Sussex, towards repairing the Church at Sussex Vale.

Resolved that the sum of £50 be granted to the Church-Wardens and Vestry of the Parish of Hampton, for the purpose of finishing that Church.

And asked leave to sit again—which report was ordered to be received.

The House then adjourned until to-morrow morning at 11 o'Clock.

Ordered that Mr. *P. Fraser* and Mr. *Campbell*, do carry up to the Council the Resolves of yesterday, and desire their concurrence thereto.

Read an engrossed Bill for the encouragement of the Trade of this Province in Plaister of Paris, otherwise called Gypsum, and on motion, ordered that the word "American" in the second section, and the words "and Oath" in the Proviso of the 4th section of this Bill be struck out.—Resolved that the Bill do pass.

Ordered that Mr. *Humbert* and Mr. *Dunn*, do carry the Bill up to the Council and desire their concurrence.

Read a second time, a Bill to regulate and lessen the expences of Trials on the Circuits, and for other purposes therein mentioned, and ordered to be committed.

The House in Committee, Mr. *R. Pagan* in the Chair, went into further consideration of Supplies to be granted to His MAJESTY for the Public service.

The *Speaker* resumed the Chair.

Mr. *R. Pagan* from the Committee, reported that he was directed by the Committee to report that they had come to sundry the following Resolves, and asked leave to sit again:

Resolved that the sum of £94:18:9 be granted to the Executors or Administrators of the late Treasurer, *William Hazen*, Esq. for contingent expences incurred by him during the last two years.

Resolved that the sum of £184:12 be granted to *John Chaloner*, Esq. for Gauging and Weighing in the years 1814 and 1815.

Resolved that the sum of £58:6:1 be granted to the Clerk of this House in addition to the former grant of £60, to defray the expence of Curtains, Stoves, Chairs, &c. for the Council Chamber and House of Assembly.

Resolved that the sum of £250 be granted to the Governor and Trustees of the College of New-Brunswick, for the year 1816, conformable to the provisions of two Acts of the General Assembly.

Resolved that the sum of £250 be granted to the President and Directors of the St. John Grammar School for the year 1816, agreeable to the provisions of two Acts of the General Assembly.

Resolved that the sum of £100 be granted to the President and Directors of the Grammar School in the Town of St. Andrews, to be applied by them towards
