

having been reported as due him from the Province, to the year 1826 inclusive, by the select Committee appointed to report upon his Petition ; to be taken out of the sum granted for the road from Fredericton to Saint Andrews the present Session.

To His Excellency the Lieutenant-Governor, or Commander-in-Chief, the sum of £260, to enable His Excellency to pay the rent of his residence in Fredericton for one year.

And the Chairman further reported, that the Committee having finished the business referred to them, it was resolved that the Committee do now rise.

Ordered, that the report be accepted.

On motion of Mr. Chandler—Resolved, that a Committee be appointed to search the Journals of the Honorable the Legislative Council, to ascertain what proceedings have been had on a Bill relative to Grammar Schools in this Province.

Ordered, that Mr. Chandler be a Committee for that purpose.

On motion of Mr. Crane.—The House went into Committee of the whole, on the Reports from the Provincial Auditor.

Mr. Taylor in the Chair of the Committee.

The Chairman reported, that having gone into further consideration of the business referred to them, he was directed to submit the following ; which he read,

No. 12. Is the audit of accounts of Thomas Wyer, Supervisor of the Great Road from St. John to St. Andrews, for the years of 1825, 1826 and 1827. This account appears to be correct. Balance due the Supervisor of 10*l*. : 16 : 3. In this account it included the expenditure of 250*l*. from the Casual Revenue, on which the Supervisor charges no commission.

E. Is the audit of the same Supervisor's account, for the year 1828. The amount of this account is 379*l*. : 5 : 6, in which is included the above balance. The account is correct. Balance due the Province 20*l*. : 14 : 6.

Nos. 6 & 7. Are the accounts of Colin Campbell, Supervisor of the Great Road from Fredericton to St. Andrews, for the years 1823 to 1827 inclusive. These accounts are correct. Balance due the Province 16*l*. : 2 : 2.

F. Is the audit of the same Supervisor's account, for the year 1828. This account is correct and satisfactory, with the exception of the vouchers Nos. 3, 4 and 5, which do not express whether the work was done by the day, or by contract. On this account there appears to be a balance of 6*l*. : 6, due this Supervisor, which, being deducted from the balance of 16*l*. : 2 : 2, due to the Province by last account, now leaves a balance due by this Supervisor, of 9*l*. : 16 : 2.

No. 5. Is the audit of accounts of the Supervisor of the Great Road from Fredericton to St. John, via. Nerepis, by which it appears that there is a balance due the Province, of 10*l*. : 6 : 3.

G. Is the audit of the same Supervisor, shewing the expenditure of 1,225*l*. : 15 : 4. In this account the Supervisor, credits an error in the account No. 7, of 14*l*. : 15 : 9, leaving a balance now due the Supervisor, of 58*l*. : 2 : 8.

The whole of the foregoing accounts are correct and satisfactory.

The Report being handed in at the Clerk's Table, was there again read, and ordered to be accepted.

Mr. Partelow, the Committee appointed to search the Journals of the Honorable the Legislative Council, to ascertain what proceedings have been had on a Bill to alter and amend the Militia Laws.
