

On motion of Mr. *Parker*, seconded by the Honorable Mr. *Brown*,

*Resolved*, That an humble Address be presented to His Excellency the Governor General, praying His Excellency to cause to be laid before this House,—a Return of the dates, and by whom made, of the several Inspections of the Inland Revenue Divisions, or Offices by the Revenue Inspectors, from the 30th June, 1865, to 30th June, 1866.

*Ordered*, That the said Address be presented to His Excellency the Governor General, by such Members of this House as are of the Honorable the Executive Council of this Province.

On motion of Mr. *Haultain*, seconded by Mr. *Cartwright*,

*Resolved*, That this House will, on Monday next, resolve itself into a Committee, to consider certain proposed Resolutions respecting the employment of Military Pensioners and others, as a local Police Force.

*Ordered*, That the Honorable Mr. Attorney General *Macdonald* have leave to bring in a Bill to incorporate the Queen's College of Physicians and Surgeons of *Kingston*.

He accordingly presented the said Bill to the House, and the same was received and read for the first time; and ordered to be read a second time, to-morrow.

The Clerk of the Legislative Council delivered, at the Bar of the House, the following Message:—

The Legislative Council have passed the following Bills, without any amendment.

Bill, intituled, "An Act to enable the Trustees of *St. Paul's* Church, *Montreal*, to "sell certain Real Estate."

Bill, intituled, "An Act to confirm the Will of the late *Robert Jackson*, of the Town- "ship of *Scarborough*."

And also, the Legislative Council have passed the following Bills of their own, to which they desire the concurrence of this House:—

Bill, intituled, "An Act to incorporate the Bank of *London*."

Bill, intituled, "An Act to enable the Honorable *Philip H. Moore*, to obtain a "Patent for the invention of a new method of manufacturing peat into coal, by process of "steam."

And then he withdrew.

On motion of the Honorable Mr. *Carling*, seconded by Mr. *Magill*,

*Ordered*, That the Bill from the Legislative Council, intituled, "An Act to incor- "porate the Bank of *London*," be now read the first time.

The Bill was accordingly read for the first time; and ordered to be read a second time, to-morrow.

On motion of Mr. *Shanly*, seconded by the Honorable Mr. *Carling*,

*Ordered*, That the Bill from the Legislative Council, intituled, "An Act to enable "the Honorable *Philip H. Moore* to obtain a Patent for the invention of a new method of "manufacturing peat into coal, by process of steam," be now read the first time.

The Bill was accordingly read the first time; and ordered to be read a second time, to-morrow.
