

**STIRRING ENTHUSIASM AT HYMAN HALL
MARKS RECEPTION TO NEW EXECUTIVE**

Mention of Hon. Mr. Hyman's Name Greeted With Tremendous Ovation.

**Mr. Beal Taken on Executive
---The Retiring President's Address.**

Hyman Hall was packed to the doors last night by the young Liberals of London, and quite a number of the older Liberals, who desired to hear the returns of the elections for the club officers. The meeting was intensely enthusiastic, and the reception given the staff for 1907 was one which must have demonstrated to them the fact that they have the undivided support of one of the finest political and social organizations in Canada.

The defeated candidates for office showed by their addresses a manly spirit, and promised to do all in their power to further the interest of the club and assist the new officers in the various duties.

Cheers For Hon. Mr. Hyman.

A feature of the evening was the demonstration evoked by a shout for a cheer for Hon. Mr. Hyman. The magic of the name moved the crowd to a pitch of enthusiasm equaling the ardor of the old days when London Liberals fought their way up with Hyman from the lower rung of a political ladder, stock to the highest position in the gift of the people of London. Cheers for cheer for "Charlie," as Mr. Hyman is known to his friends, shook the hall, old and young joining in the mighty ovation.

The New Executive.

The retiring president, the popular Harry Ramsay, took the chair, and addressed the gathering briefly. He read the following list of elected officers, which had been furnished him by Returning Officer Frank Butler:

President—Arthur Sippl.
Vice-President—Archie Black.
Secretary—Treasure—Dr. Claude Brown.

Executive—Ward 1, Dr. George Fraser; Ward 2, James McCormick; Ward 3, John Brock; Ward 4, Percy Stone; Ward 5, J. G. Arthur; Ward 6, Thomas Gerry.

He called upon each of the above-named gentlemen to take seats on the platform with him, and as each walked forward he was given an ovation by the enthusiastic gathering.

Before vacating the chair for the new president, Mr. Ramsay bespoke for the new officers the hearty goodwill and support of every Liberal in London, young and old.

"No matter how hard the officers may work," he said, "they can do nothing unless everybody takes an interest in the club."

President Sippl was cheered for five minutes when he arose to speak. He thanked his fellow Liberals for the honor they had done him in electing him to the presidency, and he promised to do his duty by the club and by Liberalism in London to the best of his ability.

"I thank you one and all for what you have done for me," he said, "but I desire to especially thank my friends from East London. I trust I will prove as good a president as the last president you had from East London, namely, the late William Wainman."

"We have, gentlemen, the finest political and social club quarters in Ontario today. We want to do our duty by this club. We want every Liberal in London, young and old, to take an interest in it, to speak a good word for it, and to help it along in every way he can. (Cheers.)"

"I know you will join me in regretting the illness of our worthy representative, Hon. C. S. Hyman, minister of public works, and I guarantee that when he returns, the young Liberals of London will give him the grandest reception ever given any man in London." (Tremendous cheering.)

Mr. Beal on Executive.
In accordance with a resolution passed at the last meeting, authorizing the president to add six names to the executive, President Sippl called Mr. Arthur Beal, the unsuccessful candidate for the presidency, to the platform, and announced that Mr. Beal would be taken on the executive.

Mr. Beal paid a warm tribute to the worth of the newly-elected president. He knew of no man in the Liberal ranks better fitted to fill the office of president than Mr. Sippl. (Cheers.) The club was very fortunate indeed to have such a body of men at the head of its affairs as those elected this year.

After addresses by Vice-President Black and the members of the executive, an entertaining programme was carried out. Mr. William Saunders favored with a solo, "The Veteran Song," and he was compelled to respond to two encores. Indeed, Mr. Saunders rather surprised his friends of the club by his splendid vocal powers. Mr. Tom Mack, the funny minstrel man, who is on at Bennett's this week, made himself solid with the club by singing songs and telling stories for half an hour. The crowd liked him so well that he had difficulty in making his escape, so as to allow someone else to have a chance on the bill.

Mr. Kenneth Finlay, the star of the Seventh Regiment Minstrels, won hearty applause for his rendition of a very fine military song and two or three popular ballads.

Mr. Chester Smith rendered a piano solo in excellent style, and Mr. M. Delaney gave a dance in a manner which won the approbation of all present.

**Another Branch Postoffice
Likely To Be Established**

A new postoffice for the northeast end of the city is a possibility in the near future.

Some time ago the people of the district lying in the County of Middlesex to the northeast of the city petitioned the Government for a postoffice. The petition was very largely signed, and it appears to have some weight with the Government.

Ex-Mayor Campbell, inspector of postoffices, is now working on the scheme, and is furnishing the department with information in case it should be decided to grant the prayer of the petition.

Today Dr. Campbell had a short talk with Mayor Judd regarding the matter. The idea of the inspector is to establish the postoffice in the extreme northeast corner of the city, if it can be located there with convenience to the people who petitioned for it.

A population of about 2,000 persons in the northeast end would be benefited by such a postoffice, which would be a branch of the central office.

At present there are postoffices at St. James' Park, in South London; Belling, in the southeast end of the city, and at Mr. A. J. Denney's, on Dundas street, near Adelaide.

The matter of establishing the new postoffice will be decided within a short time.

**NEW IMMIGRATION
INSPECTOR NAMED**

Mr. Robt. Boston, Ex-M. P., Appointed to Important Position Under Ottawa Government.

Mr. Robert Boston, ex-M. P. for South Middlesex, has been appointed an inspector of immigration by the Minister of the Interior, the head of the immigration department of Canada. Mr. Boston's duty will be to keep an eye on a certain class of emigrants, and arrange for the return of undesirable newcomers to the countries from which they were brought by steamship companies and other official agencies, London will be his headquarters, but his duties will take him to all points in the country.

Mr. Boston's appointment will give great satisfaction to his numerous friends throughout the western district, and it will be the general opinion that no better man could have been chosen for the work.

The new inspector was born in the Township of Lobo, and for twenty years continuously served in the township and county councils. He was elected member of the county in 1889. Mr. Boston was elected member of the House of Commons for South Middlesex in 1892, sitting for three years, and later he received the appointment of inspector of Middlesex county jail, a position which he held for two years.

It is safe to say that there is no more popular man in Middlesex than "Bob" Boston.

CANADA SENDS RELIEF

Steamer Beta Sails With Foodstuffs and Tents.

Halifax, N. S., Jan. 21.—The steamer Beta, which sailed from here tonight for Kingston, Jamaica, took \$16,000 worth of foodstuffs, consignments of fish, potatoes, beans, peas, butter, etc. This is sent by the Canadian Government, and is the first installment of Canada's \$50,000 voted for the relief of the earthquake sufferers. The steamer will also take 500 tents, which were supplied from the military stores at Halifax.

FUEL FAMINE AT WINNIPEG

Daily Consumption Is 100 Cars, While Only 50 Can Be Secured.

Toronto, Jan. 22.—This city faces a fuel famine. The daily consumption of coal is 100 cars, and not more than 50 can be secured. The schools will have to be closed. Many dealers cannot deliver any coal.

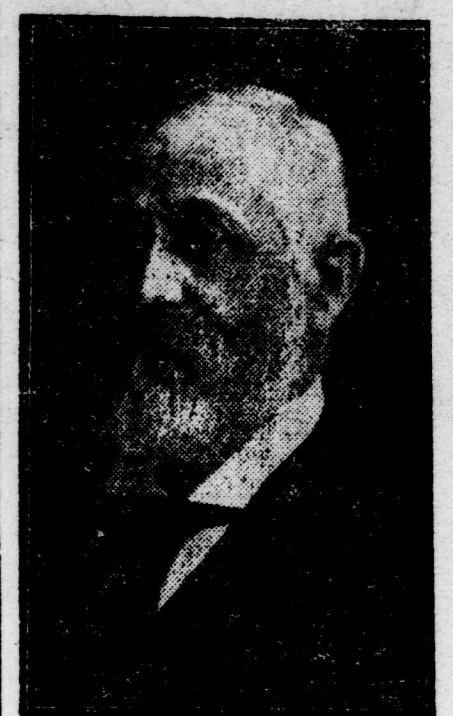
SOLDIERS RUN AMUCK

**TORONTO FIGHTS
STREET RAILWAY**

Police Compel Resumption of Old Routes and Company Withdraws Service.

AUTHOR FLYNT DEAD

Was a Nephew of Frances Willard and an Authority on Tramps.

Chicago, Jan. 22.—Josiah Flynt Willard, whose experience as a tramp, author and sociologist under the name of Josiah Flynt have given him a wide reputation, is dead of pneumonia. He was a friend of Ibsen and of Tolstol. He was born in Appleton, Wis., in January, 1868. Francis E. Willard was his aunt. He was a graduate of the University of Berlin. He had been staying for several months at the hotel where he died, while writing a series of articles exposing gambling.

CASE FELL THROUGH

Wm. Wheeler Could Not Prove Assault Charge in Police Court.

William Wheeler was one of the central figures at the police court this morning. He appeared as the complainant in a case against James Harrison, whom he accused of assault when he (Harrison) ejected him from a barroom. Wheeler could not prove the charge, and the case was dismissed.

According to Wheeler's story, Harrison had attacked him without cause, and ushered him out of the room onto the cement sidewalk in such a hurry that he fell, injuring his hand.

Harrison did not deny putting Wheeler out of the place, but he denied that he had assaulted him. He said that Wheeler had tried to interfere while he was selling some cigars to a customer. Charles Gray answered a charge of assault, laid by Hugh Horsner. The case was dismissed.

W. Best appeared on a charge of non-payment of wages laid by George Sadler. The case was adjourned for one week.

**PREMIER IN TOUCH
WITH MR. HYMAN**

To Make Definite Statement Shortly as to Resignation.

IS THERE A LUMBER COMBINE?

Motion for a Committee to Investigate the Matter Accepted by the Government.

Toronto, Jan. 21.—In the House today Sir Wilfrid Laurier, in reply to questions, stated that there was no change in the situation regarding Mr. Hyman's resignation, but that as that gentleman was now able to receive communications, he would within two weeks be in a position to make an announcement. The office of solicitor-general would be filled as soon as the tariff measure is disposed of.

Mr. Foster, who, in the absence of Mr. R. L. Borden, was leading the Opposition, asked when the position of solicitor-general, which has for a long time been vacant, would be filled. He also asked when some definite information might be expected in reference to the situation created by the resignation of the representative for London. The Opposition, he thought, the Premier would admit, had not pressed the matter unduly. But at the same time he suggested that there came an end to things, and he thought the situation by this time had become pretty well established, and that the House should have some definite information as to what the Premier proposed to do.

Sir Wilfrid Laurier, in reply, said: "With regard to the most important matter to which Mr. Foster has referred, this is the position in which the resignation of the Minister of Public Works now stands: I think that the request made by the member for North Toronto is very reasonable, and I am certain that it will be met in the manner in which he and his friends have dealt with this matter. They have shown nothing but a kindly disposition towards Mr. Hyman, and that is a disposition which we on this side most gratefully appreciate. (Heard.) It is quite natural that he should want to know something more definite. I can assure him that if very shortly—within a couple of weeks, for instance—we do not receive favorable news from Mr. Hyman, we shall have to press him for a definite answer as to his intention. His intention will be to resign, but, unfortunately, he omitted a formality which has prevented the Speaker from issuing his warrant. We have sent communications to Mr. Hyman, but unfortunately they were not able to reach him. We have reason to believe that we can reach him, and we expect to have an answer at an early day. I did not press on him my view that he should not resign his cabinet position because of reasons which induced his resignation as a member of Parliament. It may, however, happen that for reasons of ill-health we may have to accept his resignation. In making this statement I wish to express to Mr. Foster and his colleagues on the Opposition benches my gratification at the very fair manner in which the Opposition have acted in this matter. With regard to the solicitor-generalship I have said—and have no reason to change my view—that as soon as the tariff can be disposed of I shall be able to make an announcement to the House. With regard to the Australian papers I am glad to be able to gratify Mr. Foster's legitimate curiosity. These will be brought down at the end of this week, or at the latest, the beginning of next week."

**MORE QUIVERS

Two Heavy Shocks Were Felt in the Wrecked Capital of Jamaica.

New York, Jan. 22.—A dispatch from Kingston says: A heavy earthquake shock was felt here at 3 o'clock this morning, and a still heavier one 45 minutes after 2 this afternoon.

LONDON'S HEALTH GOOD

M. H. O. Says There Are Few Cases of Contagious Diseases.

"London is in a particularly healthy condition at present," Medical Health Officer Hutchinson said to The Advertiser today. "We have a case of smallpox, it is true, but it was brought to us from Oil Springs, and we only have one case of diphtheria and a couple of scarlet fever cases. The measles outbreak is subsiding and altogether it may be said of London that the city occupies an enviable position from a health standpoint."

TOLL ROAD PURCHASE

London Township's Request to Come Before Aldermen Tonight.

The regular meeting of the city council, which was scheduled for last night, but which was postponed because the city hall was being used for the Masonic reception, will be held tonight.

One of the most important matters to come up will be the request from the Township of London for a grant of \$2,000 to aid in the purchase of the Proof Line road, so that the tollgates may be abolished.

The opinion of the city fathers as to whether it would be to the city's direct interests to make a grant for the abolition of the toll road at this time. However, the question will be threshed out tonight.

THE PREFERENCE

Government Caucus Over Resolution to Confine It to Ports.

Ottawa, Jan. 22.—There was a Government caucus today to discuss Mr. Logan's resolution confining British preference to Canadian sea ports. There was strong opposition to the resolution going into effect at present. It would mean a blow to British preference. The Premier has already declared himself in favor of the principle of the resolution, but his opinion is that it is premature to put it into force now. That view will no doubt prevail. In that case a new resolution will be submitted, or Mr. Logan's will be modified, providing that it will come into effect at the time when the country is ready for it. All the western members were opposed to the increased protection which such a resolution would cause just now. They oppose anything that interferes with the British preference.

GREAT TOKIO FIRE.

Tokio, Jan. 22.—The department of communications buildings were burned today at a loss of \$500,000. Most of the documents were destroyed.

**The British Govt. Regrets
Gov. Swettenham's Letter**

U. S. State Department Informed That Inquiry Will Be Made Into the Matter—Haldane Repudiates Action of Jamaican Executive.

Washington, Jan. 22.—The state department today made public the text of the note delivered to Acting Secretary Bacon yesterday by the British embassy, as follows:

"Sir,—I have the honor to inform you, under instructions received today from his majesty's principal secretary of state for foreign affairs, that his majesty's Government are causing official inquiry to be made as to the authenticity of the letter which appeared in the public press this morning, purporting to be written by the governor of Jamaica, and addressed to Admiral Davis, commanding the United States squadron lately in Jamaican waters."

"Sir Edward Grey desires me to say that, while he is entirely dependent on the press only for information, with regard to this incident, he deeply regrets if the published text proves correct, that a British official should have addressed such a letter to the gallant admiral, who had rendered valuable assistance to British subjects at a time of great suffering and distress, and that he is certain that his feeling of regret is shared by everyone in Great Britain. 'I have the honor to be, with the highest consideration, sir, your most obedient humble servant,' (Signed) ESME HOWARD."

Deplored By People.

Philadelphia, Jan. 22.—In response to an offer of aid sent by Mayor Weaver

of this city, this cablegram was received today:

"Kingston, Jamaica, Jan. 22.—Many thanks. Money and building material urgently required. Departure of warships deplored by people. (Signed) TAIT, Mayor."

Swettenham to Root

Washington, Jan. 22.—The state department today made public the following cablegram:

Kingston, Jamaica, Jan. 20.—The Hon. E. H. Root, State Secretary, Washington, D. C., Jamaica profoundly grateful to your excellency for the very practical aid so kindly given by Admiral Davis and the entire particular service squadron of the United States navy. (Signed) Governor.

The cablegram was received in this city at 9 o'clock last night.

What Berlin Thinks

Berlin, Jan. 22.—The newspapers here print all the news available regarding the Swettenham-Davis incident, and receive the quieting statements from Washington with a certain degree of skepticism. Editorially, the incident is regarded as being more of a personal affair than an incident between the two governments, and the friction is ascribed to Swettenham's "tired nerves" and sensitive national pride. Some of the papers say that the feeling of Germany against the declaration of the United States to assist foreign relief for the San Francisco earthquake sufferers, although it is at the same time admitted that the circumstances in the two cases were quite different.

**THISTLES LIFT THE STANLEY CUP;
DEFEAT WANDERERS TWO STRAIGHT****BOULEVARD WILL
SURELY DISAPPEAR**

Extension of Business District on Dundas Street, East of Wellington, Demands It.

The steady industrial roll of the city to the eastward is causing property owners of Dundas street to sit up and take notice.

For some years a pavement for Dundas street between Wellington and Adelaide, has been talked about, and now it appears a certainty that the pavement will go down this year.

On the south side of the street, between Wellington and Waterloo, there is a boulevard of perhaps 20 feet between the sidewalk and the frontage line.

The matter of the pavement has now raised the question, will it be a good investment for the property owners of this block to allow the boulevard to remain, and keep the business away from their frontages?

Some of them think not. It is understood that the business of the McCormick Manufacturing Company is growing so rapidly that within a year or two at the outside the company must have more room.

Addition after addition has been built to the factory, but the business of the firm has increased at a greater rate than the facilities.

Sooner or later the factory will go eastward, and when it does the present building will, it is said, be cut into stores.

Thus there is a reason why the McCormicks should want the street to be paved right up to the frontage line, so as to bring the business to the stores which will most assuredly be established on the south side all the way to the armories.

At the present time all the property owners are said to be figuring very much on the future, and there is a chance that the boulevard will be wiped out altogether and that the street will be paved from walk to walk, as it is from Wellington street west.

FIRST CONTRACT LET

Cost \$2 a Foot to Bore Artesian Well at Queen's Park.

The water commissioners have let the contract for the first of the artesian wells which are to be bored, with a view to increasing the city's water supply.

The price is \$2 a foot for every foot it is sunk.

The well will be bored in the loop used by the London street railway on the Western Fair grounds in the east end.

Superintendent Moore says that even if water is struck in large quantities in the wells the cost of pumping will be very great.

If the well referred to should yield, say, 100,000 gallons per day, it will require 10-horsepower to pump it. And a 10-horsepower motor at \$50 per horsepower will cost to operate it exactly \$500 per annum.

**Spectacular Game Before 6,000
People Sends Silver Mug to the West.**

Montreal, Jan. 21.—Kenora has lifted the cup, and the famous silver mug goes west. Kenora defeated Wanderers tonight in a spectacular game by 8 to 6. The arena was crowded with over 6,000 spectators, who yelled themselves hoarse over the good plays of their respective favorites. The Wanderers replaced Kennedy at cover by Sirichan, but he was no great find, and after he had hit Hod Stuart on the head in trying to lift the puck, he was replaced by Jack Marshall, of the Montagnards. "The little man of iron," Glass was moved back, and Marshall played forward.

The game was of the whirlwind nature from the start, but during the first half many minor accidents occurred, and the casualty list grew apace; also the number who decorated the fence. Referee Chitty was strict, but impartial, and in rapid order Phillips and Glass were ruled off. Big Hod Stuart started things going for the Wanderers, and made some great rushes, and also used his great size to check counter-rushes. During the first part of the game the advantage was with the Wanderers.

Russell and Beaudro were ruled off, and during their absence Patrick, of the Wanderers, scored the first goal. Kenora followed in half a minute with a tally by Hooper, followed in another minute by a second by Hooper. Patrick was sent to the fence for cross-checking and Ross soon followed.

Phillips was the star of the Kenora team. Time and again he carried the puck through the Wanderers' line, only to lose it to Stuart, or to have his goal stopped by Harn, in the nets. Phillips scored the third goal for Kenora, and repeated in half a minute, making the score 4 to 1.

The Wanderers scored the next, and Patrick was sent to the fence for ten minutes for tripping, and Johnston for cross-checking.

Kenora's last tally in the first half was by McGimsie. This made the half-time score 5 to 2 in favor of Kenora.

The second half opened faster, and the going rang the result was in doubt. Rushes and counter-rushes, no lifting, but short passes and spectacular plays, brought the crowds to their feet again and again.

Hooper scored the sixth for Kenora, and then in rapid succession the Wanderers poured shot after shot on the Kenora goal. Ross was sent to the fence, and in his absence goals were netted for the Wanderers, making the score six all.

The even score turned the audience into a yelling, frantic mob, and it seemed as if the Wanderers would win after all, but, with only four minutes to play, Stuart was sent off for tripping Phillips. After that Kenora had things easy. With the big star gone, it was an easy matter to tally two more goals and win the match half an hour. At the end the teams were playing five a side, as McGimsie, Phillips, Patrick and Stuart were all off.

It was a hurricane finish to a game full of sensational features, and one of the fastest, cleanest games ever played here. Kenora intend playing in Ottawa on Wednesday night of this week and in Toronto Friday night. In Toronto they purpose taking the measure
