

A SCENE IN THE COUNCIL.

ALD. BAXTER EXPLAINS ABOUT HIS TRIP ACROSS THE OCEAN.

Local Health Board-Assistant Police Court Clerk, Apologist-The Mayor Makes suggestions.

After routine in the council last night Ald. Baxter rose to hurl back Ald. Hall's allegation at the last meeting that he had crossed the ocean on a free pass.

There is really bad blood existing between these two representatives and they afford their fellow members much merriment by their frequent flare-ups and recriminations.

Last night Ald. Baxter opened fire by insinuating that his St. Andrew's ward was not a man of integrity, for which he was promptly called to order by the mayor.

The weighty St. Patrick's ward then dwelt upon his blameless record as an alderman and challenged anybody to prove that he worked for the interest of any company in the council.

After a few remarks in which the speaker had gone far enough, Ald. Baxter appeared in the council for the purpose of proceeding, which was voted by a majority.

Mr. Baxter lauded at his foe a letter he had received from the Dominion Steamship Company to the effect that in July last he had purchased from them a first class return ticket to Liverpool, paying for the same in cash.

Ald. Hall was ready with a reply and boldly stated that the letter was not genuine, but he was ordered down by the mayor, and the scene was suppressed.

James Thomson requested, by letter, the council to hand over to him \$90 in payment of his expenses for promoting the Industrial exhibition association for violation of the Crooke act, the amount to come out of the separate fund account which by direction of the act is "set apart to secure prosecutions of infractions of this act."

BROWN'S BIG FIND.

The Industrial Exhibition Directors Sit on the Man who said he Found \$2000.

The directors of the Industrial exhibition met yesterday afternoon, president W. Brown in the chair, to enquire whether the reward asked for by James Brown, who alleges that he found the sum of \$2000 during the continuance of the exhibition last year, which he handed to one of the manager's clerks for safe keeping.

After informing them that he would not tell a lie for a fortune, proceeded to relate how on the morning of Sept. 13 last while engaged in sweeping out the president's and manager's offices, he found a package containing a large sum of money, more than ever he had owned before.

He then sent a policeman for one of Mr. McGee's clerks to inform him of the finding of the money. The bills were tied around with a thick cord, and neither the policeman nor he could open it with one hand.

POINTERS FOR TIPSSTAFFS.

The Sheriff Issues Printed Instructions to His Minions.

Printed instructions were yesterday handed to the tipsstaff employed in the different courts that hold forth in the Adelaide street toms. The constables are therein told their duty and how to discharge it. They are instructed in the art of managing and watching prisoners and are to be armed with a baton and revolver, and when in court with a long staff, as a mark of identity and authority.

Among the instructions are these: In conveying prisoners to and from the jail, in no case more than four prisoners occupy one cab, and to be accompanied by not less than two constables.

In cases where prisoners are charged with petty offences and have been found guilty, should accompany every two prisoners, unless otherwise ordered by the sheriff or his deputy. Every constable summoned to attend the court is to be punctual, and to be dressed in a neat and tidy manner.

Constables are not to leave the court without the permission of the sheriff or his deputy, and are to report themselves without fail at the sheriff's residence in the morning.
