Questions

2. In how many cases, by province, have revocations of such closure orders been made?

Hon. Eric W. Kierans (Postmaster General and Minister of Communications): The answer to part 1 of the question is since 25 June, 1968: Newfoundland, 58; P.E.I., 31; Nova Scotia, 121; New Brunswick, 101; Quebec, 248; Ontario, 336; Manitoba, 62; Saskatchewan, 175; Alberta, 117; British Columbia, 46; Yukon, 2; Northwest Territories, 2.

The answer to part 2 is: Newfoundland, 12; Nova Scotia, 1; New Brunswick, 1; Manitoba, 1; Saskatchewan, 3.

PERCENTAGE OF FEDERAL TAX COLLECTION SPENT BY GOVERNMENT

Question No. 1,904—Mr. Robinson:

What percentage of tax collected by the federal government has been spent by the federal government in each year 1940 to 1969 inclusive?

Hon. E. J. Benson (Minister of Finance): In each fiscal year from 1940-41 to 1968-69 total federal expenditures, including Old Age Security and contributions to provinces and municipalities, exceeded 100 per cent of the total federal tax collections with the exception of two fiscal years, 1947-48 and 1948-49 where they amounted to 89.6 per cent and 89.3 per cent respectively. It should be noted that in addition to being financed by tax revenue, federal expenditures are financed by other revenue sources, such as investment income, borrowing and reductions in the government's cash balances. Monies collected by the federal government and paid out to provinces under the Tax Collection Agreements, operative since 1962-63, have not been included.

*INDIAN AFFAIRS—DISCUSSION OF AGE OF ELECTORS

Question No. 1,907-Mr. Howard (Skeena):

- 1. Since January 1, 1970, what is the name of each Indian Band with whom the Minister of In-dian Affairs and Northern Development has discussed the question of the age of electors as defined in the Indian Act and the date of each such conversation?
- 2 What has been the view expressed by each such Band with respect to this question?

Mr. Yves Forest (Parliamentary Secretary to President of the Privy Council): 1. I have no official discussions with particular Indian bands on this question. However, the regional director in British Columbia discussed it with the chief of the Kitkatla Band and with the chief of the Nanaimo Band during the latter part of April, and discussions also took place in P.E.I. prior to the last provincial Removal expenses \$2,040.41.

elections with the chief of the reserve. The union of B.C. chiefs have been informed of the new provincial legislation and were told that possible changes are being considered by the department. In other provinces no discussions have taken place. However, I have asked my departmental officials to speak with the band leaders to receive an expression of their views.
