We stand by our agreement to the initial offer of the President of the Privy Council yesterday. May I say that in the bargaining that took place yesterday, when the hon. member for Crowfoot would not agree to Bill C-190 I made an offer to go a bit farther with the parks bill. I made that offer quite straightforwardly. One or two of my colleagues feel that they would like a committee discussion of that bill but we still agree to no further discussion in the House on that bill. I put in that point of protection, but I do think we could reach agreement on the total package after a meeting of the House leaders this afternoon, and I hope the government House leader will summon such a meeting.

Some hon. Members: Now.

Mr. André Fortin (Lotbinière): Mr. Speaker, the position of our party is as clear today as it was yesterday when, on behalf of my colleagues, I indicated our willingness to accept the government's proposition without discussion.

What really matters to us, Mr. Speaker, is that the bill concerning family allowances, although imperfect, be passed as soon as possible and without debate. It would still be an improvement over the present situation.

Now that I have risen, Mr. Speaker, I should like to clarify a point: yesterday, the hon. member for Saint John-Lancaster (Mr. Bell) and Progressive Conservative House leader stated, as reported in *Hansard* on page 8441, and I quote:

Mr. Speaker, on the same point of order, I am sure I speak for all members of my party when I say that we will give our sincere and utmost co-operation to this worth-while Christmas-like suggestion, without debate.

Mr. Speaker, I am quite surprised to see that after one day the Progressive Conservatives have started to disagree again. They are going to filibuster so as to prevent the passing of this legislation. Frankly, Mr. Speaker, I would like to suggest that the Conservatives get together for ten minutes so as to reach an agreement, come back to us afterwards and really work.
