FISHERIES

ASSISTANCE TO NEWFOUNDLAND FISHERMEN TO COMPENSATE FOR LOSSES DUE TO SEVERE ICE CONDITIONS—REQUEST FOR EXTENSION OF PROGRAM

Mr. Walter C. Carter (St. John's West): Mr. Speaker, my question is directed to the Minister of Fisheries. It concerns the statement made by him on November 9 in which he announced a program of assistance for Newfoundland fishermen who suffered losses because of ice conditions last spring. In view of the fact this program discriminates against many hundreds of Newfoundland fishermen in that those who do not live within the defined areas will not receive assistance although they suffered the same type of losses under the same conditions, would the minister give an undertaking to have this program extended so that all fishermen who have suffered losses because of the ice conditions in Newfoundland will be compensated?

Hon. Jack Davis (Minister of Fisheries): Mr. Speaker, I would be glad to give the hon. member that assurance. However, I can also tell him that, prior to the announcement of areas in which the benefits will be paid an analysis was made of the catch of the fishermen. The hon. member will be glad to know that in Newfoundland as a whole the value of the catch was up by 20 per cent.

Mr. Carter: I am aware of the formula used by the minister and his officials in arriving at this decision, but in view of the fact the formula discriminates against inshore fishermen, will the minister reconsider and extend the program to these people?

Mr. Davis: Our financial support is aimed primarily at inshore fishermen.
