3. Are supplementary estimates ever requested to cover such expenses?

4. Are additional expenses incurred in providing emergency assistance transferred to the department making the request and, if not, for what reason?

Hon. James Richardson (Minister of National Defence): 1. The Department of National Defence maintains records of recoverable costs on a case by case basis.

3. The cost of providing extensive emergency assistance could cause a shortfall in program funds, which would result in supplementary estimates.

Mr. Gaston Clermont (Parliamentary Secretary to Minister of Industry, Trade and Commerce): \$125,494.97 was spent to advertise promotion of the metric system in Canada from March 1 to March 31, 1975; the advertising agency was Maclaren Advertising Co. Ltd.

*PASSPORT OFFICE, WINNIPEG—PROCESSING OF APPLICATIONS

Question No. 2,470-Mr. Dinsdale:

1. Does the passport office in Winnipeg process applications by mail and, if not, for what reason?

2. What facilities are available to residents of Manitoba outside Winnipeg where there is urgency in processing an application?

Mr. Herb Breau (Parliamentary Secretary to Secretary of State for External Affairs): 1. Mr. Speaker, the answer to the first part of the question is no. The six Regional Passport Offices were established to bring a personalized service to as large a segment of the Canadian population as is economically feasible. They were not intended to

duplicate the mail service in Ottawa which is centralized for reasons of efficiency and economy. The difference in mailing time between Ottawa and Winnipeg or other locations in Canada is not a significant factor in the overall period of passport processing time requested on the application form of two weeks plus mailing time.

2. The answer to the second part follows. Emergency service is available at any of the six Regional Offices or at Ottawa. All Regional Offices are located in cities with major Canadian international airports from which travellers going abroad can be expected to leave Canada. This was one of the considerations in the planning of the locations of the Regional Offices which are and should be used for urgent service.
