PUBLIC SERVICE

INCREASE IN NUMBER OF HIGHER SALARIED EMPLOYEES-MOTION UNDER S.O. 43

Mr. Stan Darling (Parry Sound-Muskoka): Madam Speaker, the annual report of the Public Service Commission released yesterday showed that the number of federal public servants has significantly risen in the past year. There are now four times the number of government employees earning over \$50,000 than there were in 1981, and double the number earning between \$40,000 and \$50,000. This growth has been condoned by the government for its own questionable purposes at a time when it has been strongly urging everyone else to practise restraint. I move, seconded by the hon. member for Western Arctic (Mr. Nickerson):

That the government launch an immediate investigation into why such growth at the high salaried level of the public service was allowed and promise that, when he is finished his work in Washington, Arthur Erickson not be hired to come to Ottawa and begin designing new, palatial government buildings to house this increasingly affluent multitude.

LACK OF CONSULTATION WITH SPORTS FISHING ADVISORY COMMITTEE—MOTION UNDER S.O. 43
