(b) On occasion CBC uses the services of employment agencies when a competition within the Corporation has not yielded a suitable candidate or in order to have the widest possible choice both from inside and outside the CBC, from which to select a full-time employee. Records are not kept in such a way that the information about numbers of part-time or full-time employees in each location

can be extracted readily and without an undue amount of time, work and cost.

- 2. Such employees are paid from the CBC's regular operating budgets.
- 3. It has not been customary to require the CBC to provide such details as the costs incurred in business transactions with private companies. The background to this custom is explained in detail in the reply to question No. 2,530, May 22, 1975.
