## THE CORONR'S VERDICT

We, the jury, empanelled to enquire into the death of Albert Norris

Do find that the said Albert Norris came to his death on the morning of the 9th day of Sept. in the General Public Hospital in the city of Saint John from the effects of a violent blow causing a fracture at the base of the skull.


