FEDERAL-PROVINCIAL MEETINGS AND CONFERENCES—PARTICIPATION BY MAYORS

Question No. 2,661-Mr. Marshall:

No resolution of the sort referred to in the question has been submitted to the government.

SHIPMENTS OF CODFISH TO NIGERIA—BIAFRA Question No. 2,663—Mr. Marshall:

1. Which department and/or agency arranged for the shipments of codfish sent to Nigeria/Biafra in 1968?

- 2. Which firms performed the work connected with shipment of this fish including the work of receiving, loading and overseeing shipment?
- 3. In each case, were tenders called for this work and, if not, for what reason?
- 4. In each case, how much was paid to these firms?
- 5. Was codfish transhipped from Newfoundland to Halifax before being shipped to Africa and, if so, for what reason and at what cost?
- Hon. Mitchell Sharp (Secretary of State for External Affairs): 1. The Canadian International Development Agency in conjunction with the Fisheries Price Support Board, and the Department of National Defence.
- 2. 1st Consignment—Fisheries Price Support Board and Department of National Defence.
- 2nd Consignment—Keel Shipping Ltd., Fisheries Price Support Board, Canadian International Development Agency.
- 3. 1st Consignment—First consignment shipped by air on Department of National Defence aircraft at a cost of \$27,000.
- 2nd Consignment—Second consignment shipped by chartered vessel which carried not only fish but other foodstuffs as well as hospital supplies. Total cost of charter: \$149,021.44.
- 4. 1st Consignment—In view of urgency, first consignment purchased directly from Fisheries Price Support Board without tender call.
- 2nd Consignment—Tenders were called by Fisheries Price Support Board on behalf of the Canadian International Development Agency for the second consignment, and contracts were awarded to lowest bidders.
- 5. The fish supplied by the Fisheries Price Support Board from stocks held in Newfoundland was transported to Halifax for loading on board the chartered vessel as it was more economical to bring the fish to Halifax than to arrange for the vessel to call and load in Newfoundland. Total cost of transporting the fish from Newfoundland to Halifax amounted to \$52,732.27.
